KNOW ALL MEN BY THESE PRESENTS: That in consideration of One Hundred Thirty-One Thousand Seven Hundred Fifty Dollars and no/100 (\$131,750.00) to the undersigned Grantors in hand paid by the Grantees, whether one or more, herein, the receipt of which is hereby acknowledged, we, Randy Chapman and Norma Jean Chapman, husband & wife, (herein referred to as Grantors) do grant, bargain, sell and convey unto

Cendant Mobility Services, Inc. (herein referred to as Grantees) as individual owner or as joint tenants, with right of survivorship, if more than one, the following described real estate, situated in the State of Alabama, County of Shelby, to-wit:

And we do by these presents make, constitute and appoint **Cendant Mobility Services, Inc.** ("Agent") and/or its authorized and designated agents or representatives, as our true and lawful agent and attorney-in-fact to do and perform for us in our name, place and stead, and for our use and benefit, to execute a standard form lien waiver and any and all documents necessary for delivery of this deed and to complete the sale of the property herein described, including but not limited to the HUD-1 Settlement Statement, HUD-1 Certification, Affidavit of Purchaser and Seller, AHFA Bond Forms (Seller Affidavit), Lender Assumption Statements and/or Modification Agreement, Lender Compliance


