## **Subordination Agreement**

THIS AGREEMENT is made and entered into on this 2nd day of March2000, by AmSouth Bank (hereinafter referred to as "AmSouth") in favor of Equity National Mortgage, its successors and assigns (hereinafter referred to as "Lender").
