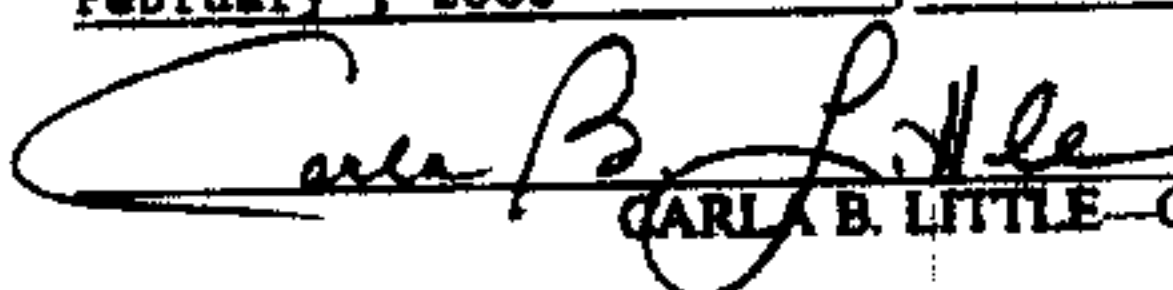
TO HAVE AND TO HOLD to the said Grantee, Grantee's heirs and assigns forever, as joint tenants with rights of survivorship.

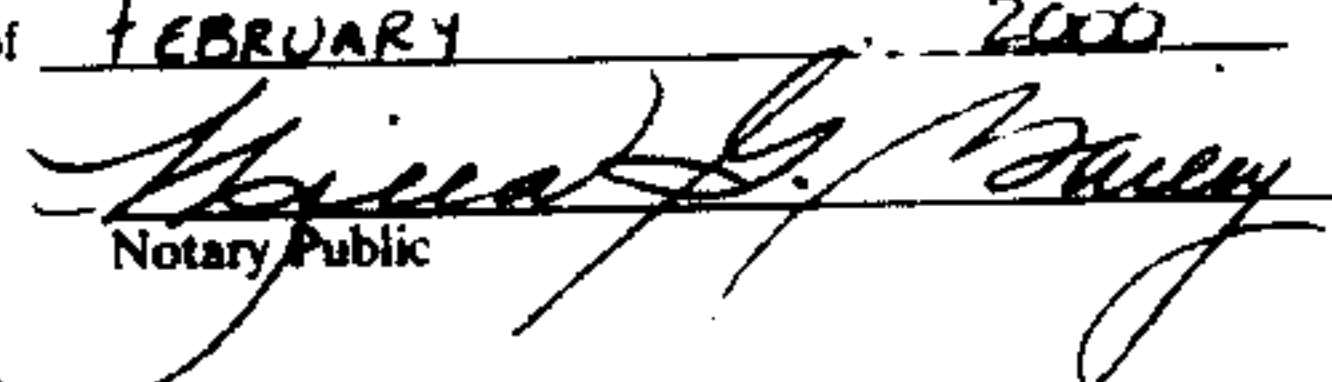

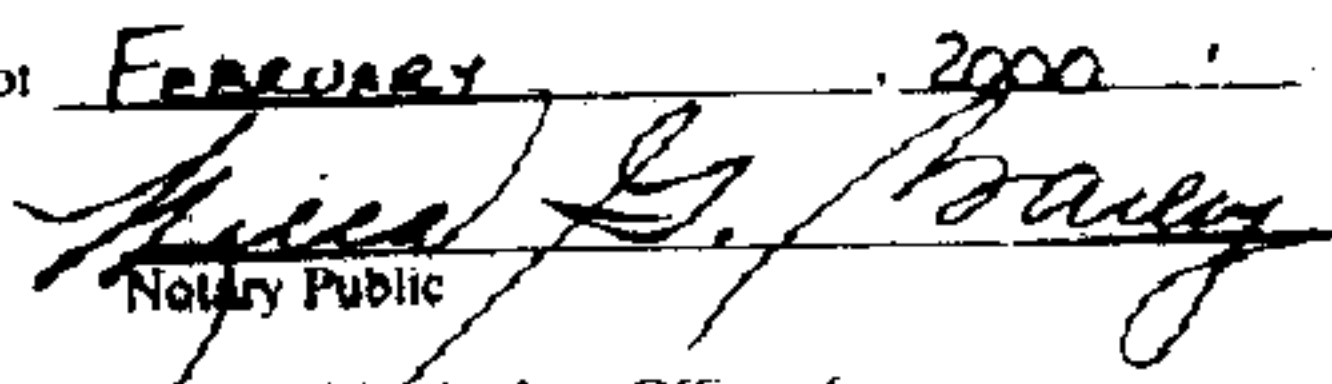
