MORTGAGE THIS IS A FUTURE ADVANCE MORTGAGE

THIS MORTGAGE IS DATED MARCH 14, 2000, between CHARLES ETRIDGEWAY and BARBARA T. RIDGEWAY, HUSBAND AND WIFE, whose address is 125 ASHFORD LN, ALABASTER, AL. 35007 (referred to below as "Grantor"); and AmSouth Bank, whose address is 1235 First Street North, Alabaster, AL. 35007 (referred to below as "Lender").

GRANT OF MORTGAGE. Grantor presently assigns to Lender all of Grantor's right, title, and interest in and to all leases of the Property and all Rents from the Property in addition, Grantor grants to Lender a Uniform Commercial Code security interest in the Personal Property and Rents.

DEFINITIONS. The following words shall have the following meanings when used in this Mortgage. Improvements. The word "Improvements" means and includes without limitation all existing and future improvements, buildings structures, mobile homes affixed on the Real Property, facilities, additions, replacements and other construction on the Real Property.

Indebtedness.
