KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of Three Hundred Twenty-Five Thousand Nine Hundred and 00/100 (\$325,900.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR, **Stylemark Homebuilders, Inc.**, a corporation (hereinafter referred to as GRANTOR), the receipt whereof is hereby acknowledged, the GRANTOR does hereby give, grant bargain, sell and convey unto the GRANTEE, **Thomas Drew McGowan and wife, Penny Diane McGowan**, (hereinafter referred to as GRANTEE), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of SHELBY, State of Alabama, to-wit
