

AGREEMENT AMONG BENEFICIARIES
TERMINATING TRUST

We, the undersigned, **JONATHAN BRUMLEY** and **BRENT BRUMLEY**, being all of the beneficiaries, under that trust created by **JUDY BRUMLEY LaCASSE**, as trustor, by the trust instrument dated April 11, 1994, naming **PATRICIA E. RANKIN (PATTI)**, as trustee, each being over 19 years of age, do, in consideration of each other's agreement, hereby agree to terminate the trust. Each of us releases and waives any right or interest he or she may have under the trust.

We further each release **PATRICIA E. RANKIN**, trustee, from all duty and liability under the trust if and when she distributes the trust assets to our mother, **JUDY BRUMLEY LaCASSE**, now **JUDY BRUMLEY**.

For reasons that are satisfactory to each of us and are known to the other beneficiary of the trust created by **JUDY BRUMLEY LaCASSE**, as trustor, by an instrument dated April 11, 1994, **JONATHAN BRUMLEY** and **BRENT BRUMLEY**, being at least 19 years of age, do hereby forever renounce and disclaim all our interest under that trust and all right, title, and interest of whatsoever nature given to us by the provisions of that trust instrument.

Each declares that each will not accept, either at present or in the future, from the trustee of the trust or the trustee's successors, any portion of the income or principal of the trust estate or any interest in it which may be sought to be paid to me in accordance with any right, title, or interest which I had at any time before the execution of this disclaimer. It is my intention in executing this disclaimer to terminate my interest in the trust as effectively as would my death.
