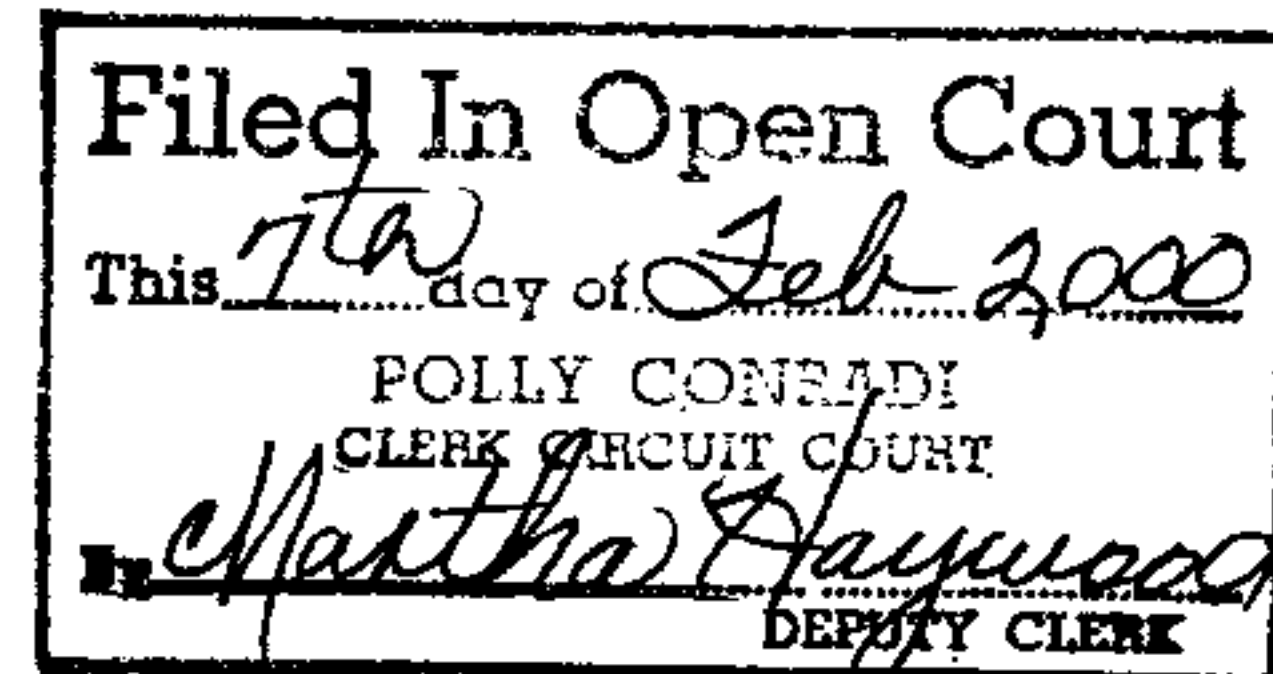

**FINAL JUDGMENT**

---

This matter came on to be heard on the Motion for Summary Judgment filed by the plaintiff, Financial Resources, LLC ("FRL") against each of the defendants. Due notice of the hearing was given to the defendants through their counsel.

The Court has reviewed the record and finds that the undisputed evidence establishes that FRL is entitled to a judgment as a matter of law. Therefore, it is hereby **ORDERED, ADJUDGED, and DECREED** as follows:

A judgment is entered in favor of the plaintiff FRL and against the Defendants Security Technical Services, Inc., Tactical Enforcement Police, Inc., John Hunter, and Jane Hunter, jointly and severally, for all of the following relief:

A. A money judgment for damages in the amount of \$234,750.93;



B. The money in the bank account at Regions Bank is to be paid to FRL and shall be applied to the amount due on the Judgment;

C. The surety bond posted by FRL is due to be released and canceled;

D. Defendants and anyone acting in concert with them are restrained and enjoined from collecting any and all monies owed to them and shall pay over all such sums immediately to FRL;

E. FRL may send a copy of this Judgment to all of any of defendants' account debtors, who are to pay any and all monies they owe to any of defendants directly to FRL and not to defendants;

F. All accounts owed to defendants are the property of FRL and FRL may collect, pursue, and recover on those accounts in its name or in the name of defendants, ~~whether or not FRL previously advanced funds to defendants for or on account of such accounts~~ *me*

G. No relief is sought or awarded against Regions Bank, other than it shall pay the proceeds of the bank account to FRL's attorney; and

H. Costs of this action are taxed against the Defendants.
