## CERTIFICATE OF AUTHORITY INDIVIDUAL ATTORNEY-IN-FACT

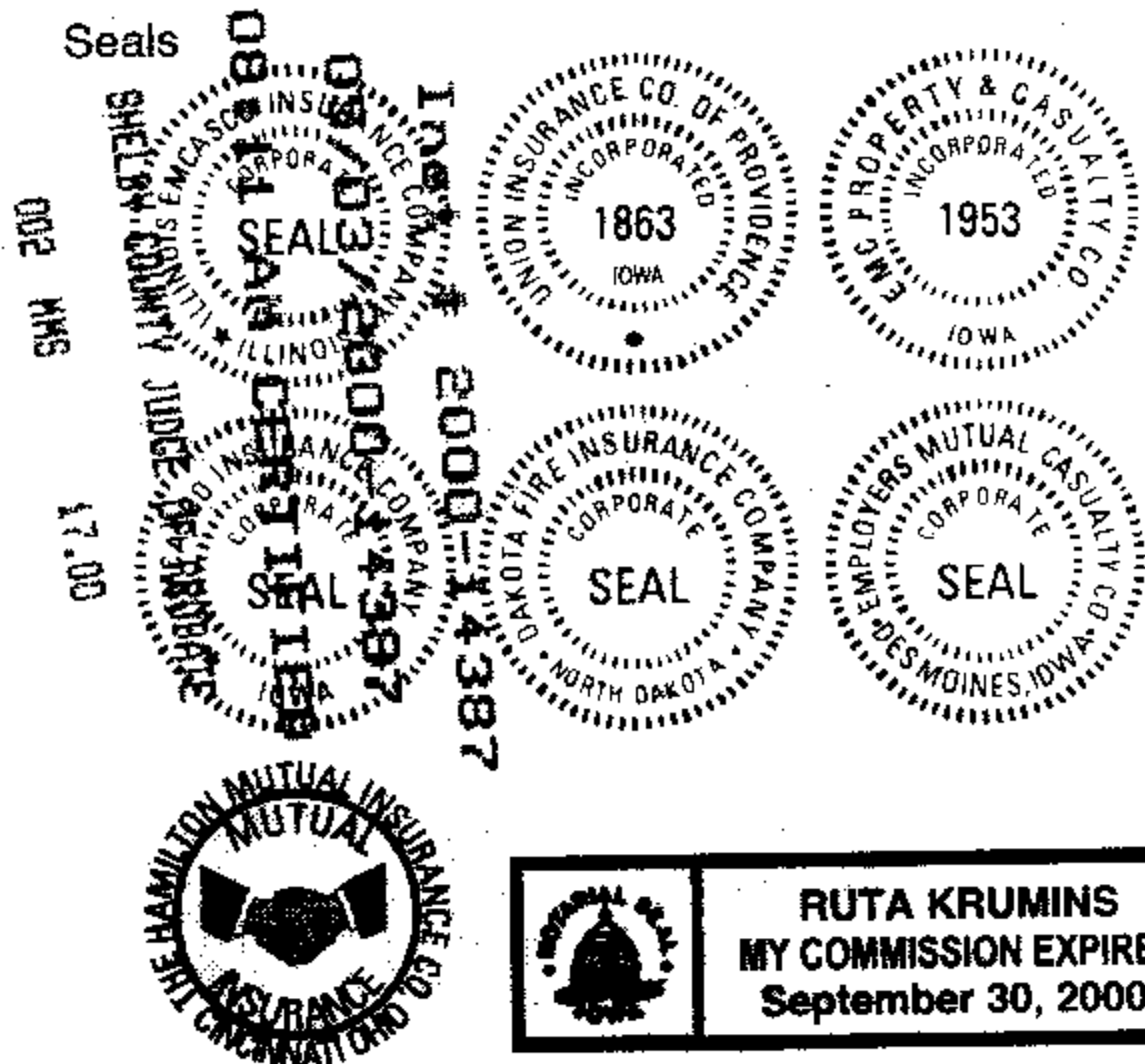
