 - (a) to declare the Obligations immediately due and payable in full, such acceleration to be automatic and immediate if the Event of Default is a filling under the Bankrupicy Code;

(b) to collect the outstanding Obligations with or without resorting to judicial process;

(c) to require Mortgagor to deliver and make evallable to Lender any personal property or Chamels constituting the Property at a place

reasonably convenient to Mortgagor and Lender;
(d) to enter upon and take possession of the Property without applying for or obtaining the appointment of a receiver and, at Lender's option, to appoint a receiver without bond, without first bringing suit on the Obligations and without otherwise meeting any statutory conditions regarding
