Mayor Lewis Walker introduced the following ordinance:

ORDINANCE NO. 06-98-01

WHEREAS, on the 16 th day of June 1998, 3-M Developers, Roy Martin, Managing Partner, being the owners of all the real property hereinafter described, did file with the City Clerk a petition asking that the said tracts or parcels of land be annexed to and become a part of the City of Columbiana; and

WHEREAS, said petition did contain the signatures of all of the owners of the described territory and a map of said property showing its relationship to the corporate limits of the City of Columbiana; and

WHEREAS, the governing body did determine that it is in the public interest that said property be annexed to the City of Columbiana and it did further determine that all legal requirements for annexing said real property have been met pursuant to Sections 11-42-20 through 11-42-24, Code of Alabama, 1975;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF COLUMBIANA, ALABAMA, AS FOLLOWS:

Section 1. The boundary lines of the City of Columbiana, Alabama, be, and the same are hereby altered or rearranged so as to include all of the territory heretofore encompassed by the corporate limits of the City of Columbiana, Alabama, and in addition thereto the following described territory, to-wit:

Commence at the Southeast corner of the SE¼ of NE¼, of Section 28, Township 21 South, Range 1 West, said point also the point of beginning; thence North 2°08'02" West along the East line of said Section 28 for a distance of 859.12 feet; thence South 87°48"08" West for a distance of 427.49 feet; thence North 2°12'11" West for a distance of 1009.79 feet to a point on the Southerly right-of-way line of Alabama Highway 70, said point also a point on a curve to the right having a radius of 5855.51 feet and a central angle of 3°04'41", said curve subtended by a chord bearing North 85°05'06" West and a chord distance of 314.53 feet; thence along the arc of said curve and along said right-of-way for a distance of 314.57 feet; thence South 6°27'15" West along said right-of-way for a distance of 20.00 feet; thence North 83°32'45" West along said right-of-way for a distance of 581.59 feet; thence South 1°51'04" East and leaving said West along said right-of-way for a distance of 2009.13 feet to the SW corner of the SE¼ of the NE¼ Section 28, Township 21 South, Range 1 West; thence North 86°21'25" East for a distance of 1329.30 feet to the point of beginning; Said parcel of land is lying in the East ½ of the NE¼ of Section 28, Township 21 South, Range 1 West.

Section 4. The territory described in this ordinance shall become a part of the corporate limits of Columbiana, Alabama, upon publication of this ordinance as set forth in Section 3, above.




