1. *Allylamine* (1.0 g, 10 mmol) was dissolved in 10 mL of water and 10 mL of 10% aqueous sodium hydroxide solution. The mixture was stirred at room temperature for 24 h. The mixture was then extracted with 10 mL of diethyl ether. The organic layer was dried over anhydrous sodium sulfate and concentrated under reduced pressure to give 1.0 g of allylamine.
