CONSTRUCTION MORTGAGE THIS IS A FUTURE ADVANCE MORTGAGE

THIS MORTGAGE IS between Jackie Williams Co., Inc., whose address is P. O. Box 598, Cheisea, Al. 35043 (referred to below as "Grantor"); and Regions Bank, whose address is 2964 Pelham Parkway, Petham. AL 35124 (referred to below as "Lender").

GRANT OF MORTGAGE. For valuable consideration, Grantor mortgages, grants, bargains, sells and conveys to Lender all of Grantor's right title, and interest in and to the following described real property, together with all existing or subsequently erected or affixed build ny improvements and fixtures; all essements, rights of way, and appurtenances; all water, water rights, watercourses and ditch rights lincluding stock in utilities with ditch or irrigation rights); and all other rights, royalties, and profits relating to the real property, including without limitation. all minerals, oil, gas, geothermal and similar matters, located in Shelby County, State of Alabama (the "Real Property"):

Lot 35, according to the Survey of Surremerchase, Phase 3, as recorded in Map Book 25, page 65, in the Probate Office of Shelby County, Alabama.

THE REAL PROPERTY DESCRIBED ABOVE DOES NOT CONSTITUTE THE HOMESTEAD OF THE GRANTOR.

The Real Property or its address is commonly known as Lot 35, Summerchase, Calera, AL 35040.

Grantor presently assigns to Lender all of Grantor's right, title, and interest in and to all leases of the Property and all Rents from the Property. in addition, Grantor grants to Lender a Uniform Commercial Code security interest in the Personal Property and Rents

DEFINITIONS. The following words shall have the following meanings when used in this Mortgage. Terms not utherwise defined in this Mortgage shall have the meanings attributed to such terms in the Uniform Commercial Code. All references to dollar amounts shall mean emounts in lawful money of the United States of America.

Grantor. The word "Grantor" means Jobkie Williams Co., Inc.: The Grantor is the mortgagor under this Mortgage

Guarantor. The word "Guarantor" means and includes without limitation each and all of the guarantors sureties, and accommodation parties in connection with the Indebtedness.

Improvements. The word "Improvements" means and includes without limitation all existing and luture improvements buildings structures, mobile homes affixed on the Real Property, facilities, additions, replacements and other construction on the Real Property

Indebtedness. The word "Indebtedness" means all principal and interest payable under the Note and any emounts expended or advanced by Lender to discharge obligations of Grantor or expenses incurred by Lender to enforce obligations of Grantor under this Mortgage together with interest on such amounts as provided in this Mortgage.

Lender. The word "Lender" means Regions Bank, its successors and assigns. The Lender is the mortgages under this Mortgage.

Mortgage. The word "Mortgage" means this Mortgage between Grantor and Lender, and includes without limitation all assignments and security interest provisions relating to the Personal Property and Rents

Note. The word "Note" means the promissory note or credit agreement dated May 12, 2000, in the original principal amount of \$78,750.00 from Grantor to Lender, together with all renewels of, extensions of, modifications of, refinencings of, consolidations of and aubstitutions for the promissory note or agreement. NOTICE TO GRANTOR: THE NOTE CONTAINS A VARIABLE INTEREST RATE

Personal Property. The words "Personal Property" mean all equipment, fixtures, and other articles of personal property now or heresiter. owned by Grantor, and now or hereafter attached or affixed to the Real Property, together with all accessions, parts, and additions to an replacements of, and all substitutions for, any of such property; and together with all proceeds uncluding without limitation all insurance proceeds and refunds of premiums) from any sale or other disposition of the Property

Property. The word "Property" means collectively the Real Property and the Personal Property

Real Property. The words "Real Property" mean the property, interests and rights described above in the "Grant of Mortgage" section

Related Documents. The words "Related Documents" mean and include without limitation all promissory notes, credit agreements linari agreements, environmental agreements, guaranties, security agreements, mortgages, deeds of trust, and all other instruments, agreements and documents, whether now or hereefter existing, executed in connection with the indebtedness

Rents. The word "Rents" means all present and future rents, revenues, income, issues, royalties, profits, and other benefits derived from the Property.

THIS MORTGAGE, INCLUDING THE ASSIGNMENT OF RENTS AND THE SECURITY INTEREST IN THE RENTS AND PERSONAL PROPERTY, IS GIVEN TO SECURE (1) PAYMENT OF THE INDESTEDNESS AND (2) PERFORMANCE OF ALL OSLIGATIONS OF GRANTOR UNDER THIS MORTGAGE AND THE RELATED DOCUMENTS. THIS MORTGAGE IS GIVEN AND ACCEPTED ON THE FOLLOWING TERMS:

PAYMENT AND PERFORMANCE. Except as otherwise provided in this Mortgage, Grantor shall pay to Lender all amounts secured by this Mortgage as they become due, and shall strictly perform all of Grantor's obligations under this Mortgage

POSSESSION AND MAINTENANCE OF THE PROPERTY. Grantor agrees that Grantor's possession and use of the Property shall be governed to the following provisions:

Possession and Use. Until in default, Grantor may remain in possession and control of and operate and manage the Property and collect the Rents from the Property.

Duty to Melotain. Grantor shall maintain the Property in tenantable condition and promptly perform all repairs, replacements are:

maintenance necessary to preserve its value. Hazardous Substances. The terms "hazardous waste," "hazardous substance," "disposal," "release," and "threatened release" as used in this Mortgage, shall have the same meanings as set forth in the Comprehensive Environmental Response, Compensation, and Liability Act of 1980, as emended, 42 U.S.C. Section 9601, et seq. ("CERCLA"), the Superfund Amendments and Resuthorization Act of 1986. Pub. L. No. 99-499 ("SARA"), the Hezardous Materials Transportation Act, 49 U.S.C. Section 1801, at seq., the Resource Conservation and Recovery Act, 42 U.S.C. Section 6901, et seq., or other applicable state or Federal laws, rules, or regulations adopted pursuant to any of the foregoing. The terms "hazardous waste" and "hazardous substance" shall also include, without limitation, petroleum and cetroleum by-products or any fraction thereof and asbestos. Grantor represents and warrants to Lender that: (a) During the period of Grantor s ownership of the Property, there has been no use, generation, manufacture, storage, treatment, disposal, release or threatened release or any hazardoùs waste or substance by any person on, under, about or from the Property; (b) Grantor has no knowledge of, or reason to believe that there has been, except as previously idisclosed to and acknowledged by Lender in writing, (i) any use, generation manufacture, storage, treatment, disposal, release, or threatened release of any hazardous waste or substance on, under, about or from the Property by any prior owners or occupants of the Property or (ii) any actual or threatened litigation or claims of any kings by any person relating to such matters; and (c) Except as previously disclosed to and adknowledged by Lender in writing, (i) neither Grantor not any tenant, contractor, agent or other authorized user of the Property shall use, generate, manufacture, store, trest, dispose of, or release any hexardous waste or substance on, under, about or from the Property and (ii) any such activity shall be conducted in compliance with all applicable federal, state, and local laws, regulations and ordinances, including without limitation those laws, regulations, and ordinances described above. Grantor authorizes Lander and its agents to enter upon the Property to make such inspections and tests, at Grantor 5 expense, se Lender may deem appropriate to determine compliance of the Property with this section of the Mortgage. Any inspections of tests made by Lender shall be for Lender's purposes only and shall not be construed to create any responsibility or hability on the part of Lender to Grantor or to any other person. The representations and warranties contained herein are based on Grantor's due diagratic or investigating the Property for hazardous waste and hazardous substances. Grantor hereby (a) releases and waives any future glaims against Lander for Indemnity or contribution in the event Grantor becomes liable for cleanup or other costs under any such laws. Area to agrees to indemnify and hold harmless Lander against any and all claims, losses, liabilities, damages, penalties, and expenses which Lenter may directly or indirectly sustain or suffer resulting from a breach of this section of the Mortgage or as a consequence of any lists generation, manufacture, storage, disposal, release or threatened release of a hazardous waste or substance on the properties. The provisions of this section of the Mortgage, including the obligation to indemnify, shall survive the payment of the Indebtedness are: 114 satisfaction and reconveyance of the lientof this Mortgage and shall not be affected by Lender's acquisition of any interest in the Profession. whether by foreclosure or otherwise.

Nulsance, Waste. Grantor shall not cause, conduct or permit any nuisance nor commit, permit, or suffer any stripping of or waste on the Property or any portion of the Property. Without limiting the generality of the foregoing, Grantor will not remove, or grant to any other party the right to remove, any timber, minerals (including oil and gas), soil, gravel or rock products without the prior written consent of Lender.

Removal of Improvements. Grantor shall not demoksh or remove any improvements from the Real Property without the prior writer consent of Lander. As a condition to the removal of any improvements, Lander may require Grantor to make arrangements satisfactors, the Lander to replace such improvements with improvements of at least equal value.

Lender's flight to Enter. Lender and its agents and representatives may enter upon the Real Property at all reasonable times to attend the Lender's interests and to inspect the Property for purposes of Grantor's compliance with the terms and conditions of this Mortgage.

Compliance with Governmental Requirements. Grantor shall promptly comply with all laws, ordinances, and requisitions now or hereafter in effect, of all governmental authorities applicable to the use or occupancy of the Property, including without limitation, the Americans With Disabilities Act. Grantor may contest in good faith any such law, ordinance, or regulation and withhold compliance during any proceeding, including appropriate appeals, so long as Grantor has notified Lander in writing prior to doing so and so long as in Cambric's sole opinion, Lender's interests in the Property are not propartized. Lander may require Grantor to post adequate segurity or a surety break reasonably satisfactory to Lander, to protect Lander's interest.

Outy to Protect. Grantor agrees neither to abandon nor leave unattended the Property. Grantor shall do all other acts, in addition to those acts set forth above in this section, which from the character and use of the Property are reasonably necessary to protect and preserve the Property.

DUE ON SALE - CONSENT BY LINDER. Lander may, at its option, declare immediately due and payable all sums secured by this Mortgage upon the sale or transfer, without the Lander's prior written consent, of all or any part of the Real Property, or any interest in the Real Property. A "sale or transfer" means the conveyance of Real Property or any right, title or interest therein; whether legal, beneficial or equitable, whether voluntary or involuntary; whether by outright sale, deed, installment sale contract, land contract, contract for deed, lessehold interest with a term greater than three (3) years, lesse-option contract, or by sale, assignment, or transfer of any beneficial interest in or to any land trust holding title to the Real Property, or by any other method of conveyance of Real Property interest. If any Grantor is a corporation, partnership interests or limited liability company, transfer also includes any change in ownership of more than twenty five percent (25%) of the voting stock, partnership interests or limited liability company interests, as the case may be, of Grantor. However, this option shall not be exercised by Lender if such exercise is prohibited by federal law or by Alabema law.

TAXES AND LIENS. The following provisions relating to the taxes and liens on the Property are a part of this Mortgage

Payment. Grantor shall pay when due (and in all events prior to delinquency) all taxes, payroll taxes, special taxes, assessments, water charges and sewer service charges levied against or on account of the Property, and shall pay when due all claims for work done on or for services randered or material furnished to the Property. Grantor shall maintain the Property free of all lians having priority over or equal to the interest of Lender under this Mortgage, except for the lien of taxes and assessments not due, and except as otherwise provided in the following paragraph.

Right To Contest. Grantor may withhold payment of any tax, assessment, or claim in connection with a good faith dispute over the obligation to pay; so long se Landar's interest in the Property is not jeopardized. If a lien arises or is filed as a result of nonpayment Grantor shall within fifteen (15) days after the lien arises or, if a lien is filed, within fifteen (15) days after Grantor has notice of the filing secure the discharge of the lien, or if requested by Lender, deposit with Lender cash or a sufficient corporate surety bond or other security satisfactory to Lander in an amount sufficient to discharge the lien plus any costs and afterneys' fees or other charges that could accrue as a result of a forediosure or sale under the lien. In any contest, Grantor shall defend itself and Lender and shall satisfy any adverse judgment before enforcement against the Property. Grantor shall name Lander as an additional obligee under any surety hand furnished in the contest proceedings.

Evidence of Payment. Grantor shall upon demand furnish to Lender satisfactory evidence of payment of the taxes or assessments and share authorize the appropriate governmental official to deliver to Lender at any time a written statement of the taxes and assessments against the Property.

Notice of Construction. Grantor shall notify Lander at least fifteen (15) days before any work is commenced, any services are furnished or any materials are supplied to the Property, if any mechanic's lien, materialmen's lien, or other lien could be asserted on account of the work, services, or materials. Grantor will upon request of Lander furnish to Lander advance assurances satisfactory to Lander that Grantor can and will pay the cost of such improvements.

PROPERTY DAMAGE INSURANCE. The following provisions relating to insuring the Property are a part of this Mortgage

Maintenance of Insurance. Grantor shall procure and maintain policies of fire insurance with standard extended coverage endorsements on a replacement basis for the full insurable value covering all Improvements on the Real Property in an amount sufficient to avoid application of any coinsurarice clause, and with a standard mortgages clause in favor of Lender. Grantor shall also procure and maintain comprehensive general liability insurance in such coverage amounts as Lender may request with Lender being named as additional insurads in such liability insurance policies. Additionally, Grantor shall maintain such other insurance, including but not limited to hazard, business interruption and boiler insurance as Lender may require. Policies shall be written by such insurance companies and in such form as may be reasonably acceptable to Lender. Grantor shall deliver to Lender cartificates of coverage from each insurar containing a stipulation mail coverage will not be cancelled or diminished without a minimum of ten (10) days' prior written notice to Lender and not containing any disclaimer of the insurar's liability for failure to give such notice. Each insurance policy also shall include an endorsement providing that coverage in favor of Lender will not be impaired in any way by any act, omission or default of Grantor or any other person.

Application of Proceeds. Grantor shall promptly notify Lender of any loss or damage to the Property. Lender may make proof of also, if Grantor fails to do so within fifteen (15) days of the casualty. Whether or not Lender's security is impaired, Eander may at its election apply the proceeds to the reduction of the Indebtedness, payment of any lien affecting the Property, or the restoration and repair of the Property. If Lander elects to apply the proceeds to restoration and repair, Grantor shall repair or replace the damaged or destroyed improvements in a manner satisfactory to Lander. Lander shall, upon satisfactory proof of such expenditure, pay or reimburse Grantor from the proceeds for the reasonable cost of repair or restoration if Grantor is not in default under this Mortgage. Any proceeds which have not been disbursed within 180 days after their receipt and which Lander has not committed to the repair or restoration of the Property shall be used first to pay any amount owing to Lander under this Mortgage, then to pay accrued interest, and the remainder if any, shall be applied to the principal balance of the Indebtedness. If Lander holds any proceeds after payment in full of the Indebtedness, such proceeds shall be paid to Grantor.

Unexpired insurance at Sale. Any unexpired maurance shall inure to the benefit of, and pass to, the purchaser of the Property covered by this Mortgage at any trustee's sale or other sale held under the provisions of this Mortgage, or at any foreclosure sale of such Property.

Grantor's Report on Insurance. Upon request of Lender, however not more than once a year, Grantor shall furnish to Lender a report on each existing policy of insurance showing: (a) the name of the insurer; (b) the risks insured; (c) the amount of the policy; (d) the property insured, the then durrent replacement value of such property, and the manner of determining that value, and (a) the expiration date of the policy. Grantor shall, upon request of Lender, have an independent appraisar satisfactory to Lender determine the cash value replacement cost of the Property.

EXPENDITURES BY LENDER. If Grantor fails to comply with any provision of this Mortgage, or if any action of proceeding is commenced this would materially affect Lender's inteleasts in the Property. Lender on Grantor's behalf may, but shall not be required to, take any agiton that Lender deems appropriate. Any amount that Lender expends in so doing will beer interest at the rate provided for in the Note from the date incurred or paid by Lander to the date of repayment by Grantor. All such expenses, at Lander's option, will (a) be payable on degrand. (b) he edded to the balance of the Note and be apportioned among and be payable with any installment payments to become due during either (i) the term of any epplicable insurance policy or (ii) the remaining term of the Note, or (c) be treated as a balloon payment which will be due and payable at the Note's maturity. This Mortgage also will secure payment of these amounts. The rights provided for in this paragraph shall be in eddition to any other rights or any remedies to which Lender may be entitled on account of the default. Any such action by Lander shall not the construed as curing the default so as to ber Lander from any remedy that it otherwise would have had.

WARRANTY; DEFENSE OF TITLE. The following provisions relating to ownership of the Property are a part of this Mortgage

Title. Granter warrants that: (a) Granter holds good and marketable title of record to the Property in fee simple, free and clear of all lights and encumbrances other than those set forth in the Real Property description or in any title insurance policy, title report or final title opinion issued in favor of, and accepted by, Lander in connection with this Mortgage, and (b) Grantor has the full right power, and authority to

Defence of Title. Subject to the exception in the paragraph above, Grantor warrants and will forever defend the title to the Property against the lawful claims of all persons. In the event any action or proceeding is commenced that questions Grantor's title or the interest of persons. under this Mortgage, Grantor shall defend the action at Grantor's expense. Grantor may be the nominal party in such proceeding for Lander shall be entitled to participate in the proceeding and to be represented in the proceeding by counsel of Lender's tiwn choice. And Grantor will deliver, or cause to be delivered, to Lender such instruments as Lender may request from time to time to permit such

Compliance With Laws. Grantor warrants that the Property and Grantor's use of the Property complies with all existing applicable in As participation. ordinances, and regulations of governmental authorities.

CONDEMNATION. The following provisions relating to condemnation of the Property are a part of this Mortgage

Application of that Proceeds. If all or any part of the Property is condemned by eminent domain proceedings or by any proceeding or purchase in lieu of condemnation, Lender may at its election require that all or any portion of the net proceeds of the award be applied to the indebtedness or the repair or restoration of the Property. The net proceeds of the sward shell mean the award after payment of at reasonable costs, expenses, and attorneys' fees incurred by Lander in connection with the condamnation

Proceedings. If any proceeding in condemnation is filed. Grantor shall promptly notify Lender in writing, and Grantor shall promptly take such steps as may be necessary to defend the action and obtain the award. Grantor may be the nominal party in such proceeding trut Lender shall be entitled to participate in the proceeding and to be represented in the proceeding by counsel of its own choice, and Granton will deliver or cause to be delivered to Lender such instruments as may be requested by it from time to time to permit such perhicipation

IMPOSITION OF TAXES, FEES AND CHARGES BY GOVERNMENTAL AUTHORITIES. The following provisions relating to governmental laires less and charges are a part of this Mortgage:

Current Taxes, Fees and Charges. Upon requist by Lander, Grantor shall execute such documents in addition to this Mortgage and levi whatever other action is requested by Lender to perfect and continue Lender's lien on the Real Property. Grantor shall reimburse Lender for ell taxes, as described below, together with all expenses incurred in recording, perfecting or continuing this Mortgage including without fimitation all taxes, fees, documentary stamps, and other charges for recording or registering this Mortgage

Taxes. The following shall constitute taxes to which this section applies. (a) a specific tax upon this type of Mortgage or upon all or at a part of the Indebtedness secured by this Mortgage; (b) a specific tax on Grantor which Grantor is authorized or required to deduct from payments on the Indebtedness secured by this type of Mortgage; (c) a tax on this type of Mortgage chargeable against the Lender or the holder of the Note; and (d) a specific tax on all or any portion of the Indebtedness or on payments of principal and interest made by

Subsequent Taxes. If any tax to which this section applies is enacted subsequent to the date of this Mortgage, this event shall have the same affect as an Event of Default (as defined below), and Lender may exercise any or all of its evailable remedies for an Event of Default as provided below unless Grantor either. (a) pays the tax before it becomes delinquent or. (b) contests the tax as provided above in the Taxes and Lienz section and deposits with Lender cash or a sufficient corporate surety bond or other security satisfactory to Lander

SECURITY AGREEMENT; FINANCING STATEMENTS. The following provisions relating to this Mortgage as a security agreement are a part of this Mortgage.

Security Agreement. This instrument shell constitute a security agreement to the extent any of the Property constitutes fortunes or other personal property, and Lender shall have all of the rights of a secured party under the Uniform Commercial Code as amended from time to

Security Interest. Upon request by Lender, Grantor shall execute financing statements and take whatever other action is requested by Lander to perfect and continue Lander's security interest in the Rents and Personal Property. In addition to recording this Mortgage in the real property records. Lender may, at any time and without further authorization from Grantor, file executed counterparts, copies of reproductions of this Mortgage as a financing statement. Grantor shall reimburse Lender for all expenses incurred in perfecting or continuing this security interest. Upon default, Grantor shall assemble the Personal Property in a manner and at a place reasonably convenient to Grantor and Lender and make it available to Lender within three (3) days after receipt of written demand from Lender

Addresses. The mailing addresses of Grantor (debtor) and Lender (secured party), from which information concerning the security interest granted by this Mortgage may be obtained leach as required by the Uniform Commercial Code), are as stated on the first page of this

FURTHER ASSURANCES; ATTORNEY-IN-FACT. The following provisions relating to further assurances and attorney in-fact are a part of this Mortgage.

Further Assurances. At any time, and from time to time, upon request of Lender, Grantor will make, execute and deliver, or will cause to be made, executed or delivered, to Lender or to Lender's designee, and when requested by Lender, cause to be filed, recorded, refiled or rerecorded, as the case may be, at such times and in such offices and places as Lander may deem appropriate, any and all such mortgages deeds of trust, security deeds, security agreements, financing statements, continuation statements, instruments of further assurance certificates, and other documents as may, in the soli opinion of Lender, be necessary or desirable in order to effectuate, complete, perfect continue, or preserve. (a) the obligations of Grantor under the Note, this Mortgage, and the Related Documents, and (b) the liens and security interests created by this Mortgage as first and prior liens on the Property, whether now owned or hereafter acquired by Granton Unless prohibited by lew or agreed to the contrary by Lender in writing, Grantor shall reimburse Lender for all costs and expenses incurred in connection, with the metters referred to in this paragraph.

Attorney-In-Fect. If Grantor falls to do any of the things referred to in the preceding paragraph. Lender may do so for and in the name of Grantor and at Grantor's expense. For such purposes, Grantor hereby irrevocably appoints Lander as Grantor's attorney in fact for the purpose of making, executing, delivering, filing, recording, and doing all other things as may be necessary or desirable in Lender's sole opinion, to accomplish the metters referred to in the preceding paragraph.

FULL PERFORMANCE. If Grantor pays all the indebtedness, including without limitation all advances secured by this Mortgage, when due and otherwise performs all the obligations imposed upon Grantor under this Mortgage. Lender shall execute and deliver to Grantor a sustation satisfaction of this Mortgage and suitable statements of termination of any financing statement on file evidencing cender's security interest in the Rents and the Personal Property. Grantor will pay, if permitted by applicable law, any reasonable termination fee as determined by tander

DEFAULT. Each of the following, at the option of Lander, shall constitute an event of default ("Event of Default") under this Mortgage

Default on Indebtedness. Failure of Grantor to make any payment when due on the Indebtedness

Default on Other Payments. Fallure of Grantor within the time required by this Mortgage to make any payment for taxes or insurance in any other payment necessary to prevent filing of or to affect discharge of any lien

Compliance Default. Feiture of Grantor to comply with any other term, obligation, covenant or condition contained in this Mortgage the Note or in any of the Related Documents.

Default in Favor of Third Parties. Should Grantor default under any loan, extension of credit, security agreement, purchase or sales agreement, or any other agreement, in favor of any other creditor or person that may materially affect any of Grantor's property of Grantor's ability to repay the Note or Grantor's ability to perform Grantor's obligations under this Mortgage or any of the Related Documents.

False Statements. Any warranty, representation or statement made or furnished to Lender by or on behalf of Grantor under this Mortgage the Note or the Related Documents is false or misleading in any material respect, either now or at the time made or furnished

Defective Collegeralization. This Mortgage or any of the Related Documents ceases to be in full force and effect (including failure of any collegeral documents to create a validation perfected security interest or lien) at any time and for any reason.

Insolvency. The dissolution or termination of Grantor's existence as a going business, the insolvency of Grantor, the appointment of a receiver for any part of Grantor's property, any assignment for the benefit of creditors, any type of creditor workout, or the commencement of any propeeding under any bankruptcy or insolvency laws by or against Grantor.

Forecipeurs, Forfeiture, etc. Commencement of foreclosure or forfeiture proceedings, whether by judicial proceeding self-help representations or any other method, by any creditor of Grantor or by any governmental agency against any of the Property.
