THIS MORTGAGE dated March 27, 2000, is made and executed between JOHN B. LORINO; A. SINGLE PERSON (referred to below as "Grantor") and SouthTrust Bank, National Association, whose address is Hoover 323, 1600 Montgomery Highway, Hoover, AL 35216 (referred to below as "Lender").

GRANT OF STORTGAGE. Specifically, in addition to the amounts specified in the indebtedness definition, and without limitation, this Mortgage secures a revolving line of credit, which obligates Lander to make advances to Grantor so long as Grantor compiles with all the terms of the Credit Agreement. Compliance with Governmental Requirements. Grantor shall promptly comply with all laws, ordinances, and regulations now or hereafter in effect; of all governmental authorities applicable to the use or occupancy of the Property. PROPERTY DAMAGE INSURANCE. The following provisions relating to insuring the Property are a part of this Mortgage

Maintenance of insurance. Grantor shall procure and maintain policies of fire insurance with standard extended coverage endorsements or a replacement basis for the full insurable value covering all improvements on the Real Property in an amount sufficient to avoid application of any colonsurance clause, and with a standard mortgages clause in favor of Lander, Policies shall be written by such insurance companies and in such form as may be reasonably acceptable to Lander.
