Council member Farr introduced the following ordinance:

ORDINANCE NO. 05-00-02

WHEREAS, on the 15th day of May, 2000 Marshall Hughes and wife Lorine Hughes, being the owners of all the real property hereinafter described, did file with the City Clerk a petition asking that the said tracts or parcels of land be annexed to and become a part of the City of Columbiana; and

WHEREAS, said petition did contain the signatures of all of the owners of the described territory and a map of said property showing its relationship to the corporate limits of the City of Columbiana; and

WHEREAS, the governing body did determine that it is in the public interest that said property be annexed to the City of Columbiana and it did further determine that all legal requirements for annexing said real property have been met pursuant to Sections 11-42-20 through 11-42-24, Code of Alabama, 1975;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF COLUMBIANA, ALABAMA, AS FOLLOWS:

Section 1. The Council of the City of Columbiana, Alabama, finds and declares as the legislative body of the City that it is in the best interests of the citizens of the City, and the citizens of the affected area, to bring the territory described in Section 2 of this ordinance into the City of Columbiana.

Section 2. The boundary lines of the City of Columbiana, Alabama, be, and the same are hereby altered or rearranged so as to include all of the territory heretofore encompassed by the corporate limits of the City of Columbiana, Alabama, and in addition thereto the following described territory, to-wit:

Commence at the NW corner of the NW1/4 of the NE1/4 of Section 34, Township 21 South Range 1 West, and run South 4 deg. 48 min. 37 sec. West along the West line of said 1/4-1/4 Section a distance of 528,90 feet to a point; thence run South 71 deg. 41 min. 10 sec. East a distance of 127.54 feet to a point; thence run South 80 deg. 43 min 20 sec. East a distance of 59.91 feet to a point; thence run South 77 deg. 57 min. 20 sec. East a distance of 65.82 feet to the point of beginning of the property herein described; thence run South 70 deg. 47 min. 02 sec. East a distance of 24.03 feet to a point; thence run North 21 deg. 00 min. 00 sec. East a distance of 36.00 feet to a point; thence run South 69 deg. 00 min. 00 sec. East a distance of 102.01 feet to a point; thence run South 47 deg. 29 min. 60 sec. East a distance of 109.00 feet to a point; thence run North 57 deg. 32 min. 14 sec. East a distance of 276.23 feet to a point; thence run North 28 deg. 47 min. 45 sec. West a distance of 316.76 feet to a point; thence run South 75 deg 43 min. 35 sec. West a distance of 337.18 feet to a point; thence run South 51 deg. 57 min. 37 sec. West a distance of 15.29 feet to a point; thence run South 40 deg. 52 min. 30 sec. West a distance of 22.13 feet to the point of beginning. Said parcel of land is lying in the NW¼ of NE¼, Section 34, Township 21 South, Range 1 West and contains approximately 31/4 acres.

Section 3. This ordinance shall be published as provided by law, and a certified copy of same, together with a certified copy of the petition of the property owners, shall be filed with the Probate Judge of Shelby County, Alabama.

Section 4. The territory described in this ordinance shall become a part of the corporate limits of Columbiana, Alabama, upon publication of this ordinance as set forth in Section 3, above.


