## Articles of Incorporation of Christian Life Church

of the Assemblies of God, Inc.

These Articles of Incorporation replace any previously filed copies.

The undersigned, for the purposes of forming a nonprofit corporation under Chapter 3A Title 10 Code of Alabama, 1975, as amended of the laws of the State of Alabama, do hereby make and adopt the following Articles of Incorporation:

#### **ARTICLE 1**

#### **NAME**

The name of the Corporation is: Christian Life Church of the Assemblies of God, Inc.

#### **ARTICLE 2**

#### **NOT FOR PROFIT**

The Corporation is a nonprofit corporation under the laws of the State of Alabama. The Corporation is not formed for pecuniary profit. No part of the income or assets of the Corporation is distributable to or for the benefit of its Members, Trustees/Directors, or Officers, except to the extent permissible under law.

#### **ARTICLE 3**

#### **DURATION**

The duration (term) or the Corporation is perpetual.

#### **ARTICLE 4**

#### **PURPOSES**

The Corporation is organized, and shall be operated exclusively for, the following purposes:

A. To establish and conduct a church or church organization to be known as the Assemblies of God, for the propagation and dissemination of the Gospel of Christ.

B. To establish and conduct a suitable organization to hold, manage and maintain the property and affairs of the Corporation all under and subject to the provisions of Title 10, Article 3A of the Code of Alabama of 1975 and the amendments thereof.

To exercise all rights and powers conferred by the laws of the State of Alabama upon nonprofit corporations, including without limiting the generality of the foregoing, to acquire by bequest, devise, gifts, purchase, lease or otherwise any property of any sort or nature without limitation as to its amount or value, and to hold, invest, reinvest, manage, use, apply, employ, sell, expend, disburse, lease, mortgage, convey, option, donate or otherwise dispose of such property and the income, principal and proceeds of such property, for any of the purposes set forth herein.

C. To do such other things as are incidental to the purposes of the Corporation or

necessary or desirable in order to accomplish them.

#### **ARTICLE 5**

#### LIMITATION

No part of the net earnings of the Corporation shall inure to the benefit of or be distributed to its Members, Trustees/Directors, or Officers, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 4 (Purposes) hereof.

#### **ARTICLE 6**

#### **MEMBERS**

The Corporation shall have Voting Members who shall be elected (and may be removed) by the Voting Members and shall have all the rights and privileges of members of the Corporation. The Bylaws may provide for Nonvoting Members of one or more classes, who shall be admitted in such manner and who shall have such rights and privileges as are set forth in the Bylaws but who shall not have the right to vote. The name and address of each initial Voting Member is as follows: (Membership list is attached hereto.)

#### **ARTICLE 7**

## REGISTERED OFFICE AND AGENT

The street address of the initial Registered Officer of the Corporation is 2029 King Stables Road, Birmingham, Alabama 35242, and the name of its initial Registered Agent at that address is Reverend Danny DuVall.

#### **ARTICLE 8**

## BOARD OF TRUSTEES/DIRECTORS

The number of Trustees/Directors is three (3). The number of Trustees/Directors may be increased or decreased from time to time in accordance with the Bylaws, but shall never be less than three (3). The Voting Members shall elect the Trustees annually. The Bylaws may provide for ex officio and honorary Trustees/Directors, and their rights and privileges. The name and address of each initial Trustee/Director of the Corporation is as follows:

#### **ARTICLE 9**

#### **OFFICERS**

The Officers of the Corporation shall consist of a President, Secretary, Treasurer and such other Officers and assistant Officers as may be provided in the Bylaws. Each Officer shall be elected by the Board of Trustees/Directors (and may be removed by the Board of Trustees/Directors) at such time and in such manner as may be prescribed by the Bylaws. #### **ARTICLE 10**

#### **BYLAWS**

The Bylaws of the Corporation are to be made and adopted by the Board of Trustees, and may be altered, amended or rescinded by the Board of Trustees.

#### **ARTICLE 11**

#### **AMENDMENT**

The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, and all rights and privileges conferred upon the Members, Trustees/Directors, and Officers are subject to this reservation. The Articles of Incorporation may be amended in accordance with the provisions of the laws of the State of Alabama, as amended from time to time, unless more specific provisions for amendments are adopted by the Corporation pursuant to law.

#### **ARTICLE 12**

#### INDEMNIFICATION

The Corporation shall indemnify each Officer and Trustee/Director, including former Officers and Trustees/Directors, to the full extent permitted by the laws of the State of Alabama.

#### **ARTICLE 13**

### COMMENCEMENT OF CORPORATE EXISTENCE

In accordance with Section 10-3A-63 Code of Alabama, 1975, the date when corporate existence shall commence is the date of filing these incorporation papers with the Judge of Probate of Shelby County, Alabama.

#### **ARTICLE 14**

#### DISSOLUTION

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, state, or Local government for exclusive public purpose.


