

**AMENDED ARTICLES OF ORGANIZATION
OF
MARATHON INTERNET DATA GROUP, L.L.C.**

Pursuant to the Provisions of Act No 93-724 of the 1993 Alabama Legislature, the undersigned hereby adopt the following Limited Liability Company Articles of Organization:

**ARTICLE I
THE NAME OF THE LIMITED LIABILITY COMPANY IS:**

The name of the limited liability company is **MARATHON INTERNET DATA GROUP, L.L.C.**, hereinafter referred to in these Articles of Organization as the "Company."

**ARTICLE II
DURATION**

The period of duration is perpetual; provided however, that the Company shall cease to exist upon the winding up of its affairs and its dissolution in accordance with Section 37 of the Alabama Limited Liability Company Act (the "Act").

**ARTICLE III
PURPOSES**

The purpose for which the Company is organized is the transaction of any and all lawful business for which a limited liability company may be organized under the Act, including, without limitation, the following:

- a. To provide computer data storage, database maintenance and reporting solutions to third party businesses and organizations.
- b. To acquire, own, sell, exchange, mortgage, lease, operate, improve, develop or otherwise deal in real estate, building, office space or any interest therein.
- c. To accomplish any lawful business whatsoever or which shall at any time appear to be conducive to or expedient for the protection or benefit of the Company or its property.
- d. To exercise all other powers necessary to or reasonably connected with the Company's business which may be legally exercised by limited liability companies under the Act or under the laws of any jurisdiction in which the Company may conduct its business.
- e. To engage in all activities necessary, customary, convenient, or incident to any of the foregoing.
