#### MORTGAGE

MAXING LIEN. The Hen of this Mortgage shall not exceed at any one time \$75,000.00.

THIS MONTGAGE deted April 5, 2000, is made and executed between LARRY E CARTER and JEAN S CARTER; HUSBAND AND WIFE (referred to below as "Grantor") and SouthTrust Bank, National Association, whose address is Pelham 338, 3145 Highway 31 South, Pelham, AL 35124 (referred to below as "Lender").

GRANT OF NORTGAGE. For valuable consideration, Grantor mortgages, grants, bargains, sells and conveys to Lender all of Grantor's right, title, and interest in and to the following described real property, logether with all existing or subsequently arected or affored buildings, improvements and and interest in and to the following described real property, water rights, wetercourses and ditch rights (including stock in utilities with drich or solutions, rights of way, and appurtenences; all water, water rights, wetercourses and ditch rights (including stock in utilities with drich or solution rights); and all other rights, royalties, and profits retailing to the real property, including without kritistion all minerals, oil, gas, geothermal and similar matters, (the "Real Property") located in SHELEY County, State of Alaborna:

The Real Property or its address is commonly known as 120 CHESHIRE LANE, PELHAN, AL 35124.

REVOLVING LINE OF CRIEDIT. Specifically, in addition to the amounts specified in the indebtedness definition, and without limitation, this being secures a revolving line of credit, which obligates Lender to make advances to Grantor so long as Grantor compiles with all the terms of the Credit Agreement. Such advances may be made, repeld, and remade from time to time, subject to the limitation that the total quistanding belance outrig at any one time, not including finance charges on such balance at a fixed or variable rate or sum as provided in the quistanding belance outrig at any one time, not including finance charges on such balance at a fixed or variable rate or sum as provided in the Gradit Agreement, any temporary overages, other charges, and any amounts expended or advanced as provided in either the indebtedness paragraph or this paragraph, shall not exceed the Credit Limit as provided in the Credit Agreement. THIS MORTGAGE IS GIVEN AND ACCEPTED ON THE FOLLOWING TERMS:

PAYMENT AND PERFORMANCE. Except as otherwise provided in this Mortgage, Grantor shall pay to Lender all amounts secured by this Mortgage as they become due and shall strictly perform all of Grantor's obligations under this Mortgage.

POSSESSION AND MAINTENANCE OF THE PROPERTY. Grantor agrees that Grantor's possession and use of the Property shall be governed by the following provisions:

Possession and Use. Until the occurrence of an Event of Delaut, Grantor may (1) remain in possession and control of the Property; (2) use, operate or manage the Property; and (3) collect the Renia from the Property.

Duty to Maintain. Grantor shall maintain the Property in good condition and promptly perform all repairs, replacements, and maintain necessary to preserve its value.

Compliance With Environmental Laws. Grantor represents and warrants to Lander that: (1) During the period of Granton's ownership of the Property, there has been no use, generation, menulacture, storage, treatment, disposal, release or threatened release of any Hazardous Substance by any person on, under, about or from the Property; (2) Grantor has no knowledge of, or reason to believe that there has been, except as previously disclosed to and acknowledged by Lender in writing, (a) any breach or violation of any Environmental Laws, (b) any use, generation, manufacture, storage, trestment, disposal, release or threatened release of any Hazardous Substance on, under, about or from the Property by any prior owners or occupants of the Property, or (c) any actual or threatened Higelion or claims of any kind by any person relating to such matters; and (3) Except as previously disclosed to and acknowledged by Lender in writing, (a) neither Grantor nor any tenent, contractor, agent or other authorized user of the Property shall use, generate, manufacture, store, treat, dispose of or release any Hazardous Substance on, under, about or from the Property; and (b) any such activity shall be conducted in compliance with all applicable federal, state, and local laws, regulations and ordinances, including without smitation all Environmental Laws. Grantor authorizes Lender and its agents to enter upon the Property to make such inspections and tests, at Grantor's expense, as Lender may deem appropriate to determine compliance of the Property with this section of the Mortgage. Any inspections or tests made by Lender shall be for Lender's purposes only and shall not be construed to create any responsibility or liability on this part of Lander to Grantor or to any other person. The representations and warrantees contained herein are based on Grantor's due diligence in investigating the Property for Hazardous Substances. Grantor hereby (1) releases and waives any future claims against Lender for Indemnity or contribution in the event Grantor becomes liable for cleanup or other costs under any such laws; and (2) agrees to indemnify and hold harmines Lender against any and all claims, losses, habities, damages, penalties, and expenses which Lander may directly or indirectly sustain or sulfar resulting from a breach of this section of the Mortgage or as a consequence of any use. generation, menutacture, storage, disposal, release or threatened release occurring prior to Grantor's ownership or interest in the Property. whether or not the same was or should have been known to Grantor. The provisions of this section of the Mortgage, including the obligation to indemnity, shall survive the payment of the indebtedness and the satisfaction and reconveyance of the lien of this Mortgage and shall not be affected by Lender's acquisition of any interest in the Property, whether by foreclosure or otherwise.

Nuisance, Waste. Grantor shall not oause, conduct or permit any nuisance nor commit, pelmit, or suffer any simpping of or weste on or to the Property. Without limiting the generality of the foregoing, Grantor will not remove, or grant to any other party the right to remove, any timber, minerals (including oil and just), coal, play, sooris, soil, gravel or rock products without Lender's prior written consent.

Removal of Improvements. Grantor shall not demailsh or remove any Improvements from the Real Property without Lender's prior written consent. As a condition to the removal of any Improvements, Lender may require Grantor to make arrangements satisfactory to Lender to replace such Improvements with improvements of at least equal value.

Lender's Right to Enter. Lender and Lender's agents and representatives may enter upon the Real Property at all reasonable times to attend to Lender's interests and to inspect the Real Property for purposes of Grantor's compliance with the terms and conditions of this Mortgage.

Compliance with Covernmental Requirements. Grantor shall promptly comply with all laws, ordinances, and regulations, now or haraster in effect, of all equiremental authorities applicable to the use or occupancy of the Property. Grantor may contest in good telth any such law, ordinance, or regulation; and withhold compliance during any proceeding, including appropriate appeals, so long as Grantor has notified Lender in writing girter to stoing so and so long as, in Lander's site opinion, Lender's interests in the Property are not jeopardized. Lender may require Grantor to post adequate security or a surely bond, resemble satisfactory to Lender, to protect Lender's interest.

Duty to Protect. Grantor agrees neither to abandon nor leave unattended the Property. Grantor shall do all other acts, in addition to those acts and texth above in this section, which from the character and use of the Property are reasonably necessary to protect and preserve the Property

DUE ON BALE - CONSENT BY LENDER. A "sale or transfer" means the conveyance of Real Property or any right, like or interest in the Real Property; whether legal, beneficial or equitable; whether voluntary or involuntary; whither by outright sale, deed, installment sale contract, land contract, contract for deed, leasehold interest with a term greater than three (3) years, lease-botton contract, or by sale, assignment, or transfer of any beneficial interest in or to any land trust holding title to the Real Property, or by any other method of conveyance of an interest in the Real Property. Permitted. Evidence of Payment. Grantor shall upon demand fumish to Lender satisfactory evidence of payment of the taxes or assessments and shall authorize the appropriate governmental official to deliver to Lender at any time a written statement of the taxes and assessments against the Property.

feetice of Construction. Grantor shall notify Lender at least lifeen (15) days before any work is commenced, any services are furnished, or any materials are supplied to the Property, if any mechanic's item, meterialmen's item, or other lien could be asserted on account of the work, services, or materials. Grantor will upon request of Lender furnish to Lender advance essurances satisfactory to Lender that Grantor can and will pay the cost of such improvements.

PROPERTY DAMAGE INSURANCE. The following provisions righting to insuring the Property are a part of this Mortgage:

Maintenance of Insurance. Grantor shall procure and maintain policies of fire insurance with standard extended coverage endorsements on a replacement basis, for the full insurable value covering all improvements on the Real Property in an amount sufficient to avoid application of any coinsurance clause, and with a standard mortgages clause in tevor of Lender. Policies shall be written by such insurance companies and in such form as may be reasonably acceptable to Lender. Girentor shall deliver to Lender dertificates of coverage from each insurer containing a stipulation that coverage will not be cancelled or diministrated without a minimum of ten (10) days' prior written notice to Lender and not containing any disclaimer of the insurer's fability for fature to give such notice. Each insurance policy also shall include an endorsement providing that coverage in taxon of Lender will not be impaired in any way by any act, omission or default of Grantor or any other person. Should the Real Property be located in an area designated by the Director of the Federal Emergency Management Agency as a special flood hazard area, for the full unpaid principal belance of the loan and any pinor liens on the property securing the loan, up to the maximum policy limits set under the Netional Flood Insurance Program, or as otherwise required by Lender, and to maintain such insurance for the term of the loan.

Application of Proceeds. Grantor shall promptly notify Lender of any loss or damage to the Property. Lender may make proof of loss if Grantor talls to do so within fifteen (15) days of the casualty. Whether or not Lender's security is impaired, Lender may, at Lender's election, receive and retain the proceeds of any insurance and apply the proceeds to the reduction of the Indebtedness, payment of any len affecting the Property, or the restoration and repair of the Property. If Lender elects to apply the proceeds to restoration and repair, Grantor shall repeir or replace the demaged or destroyed Improvements in a manner satisfactory to Lender. Lender shall, upon satisfactory proof of such expenditure, pay or reimburse Grantor from the proceeds for the reasonable cost of repair or restoration if Grantor is not in default under this Mortgage. Any proceeds which have not been desturised within 180 days after their receipt and which Lender has not committed to the repair or restoration of the Property shall be used first to pay any amount owing to Lender under this Mortgage, then to pay accrued interest, and the remainder, if any, shall be applied to the principal belence of the Indebtedness. If Lender holds any proceeds after payment in full of the Indebtedness, such proceeds shall be oaid to Grantor as Grantor's interests may appear.

Unexpired incurance at Sale. Any unexpired insurance shell inure to the benefit of, and pass to, the purchaser of the Property covered by this Mortgage at any trustee's sale or other sale held under the provisions of this Mortgage, or at any foreclosure sale of such Property.

LEMBER'S EXPENDITURIES. If Grantor falls. (A) to keep the Property free of all taxes, liens, security interests, encumbrances, and other claims. (B) to provide any required insurance on the Property, or. (C) to make repairs to the Property then Lender may do so. If any action or proceeding is commenced that would materially affect Lender's interests in the Property, then Lender on Grantor's behalf may, but is not required to, take any action that Lender believes to be appropriate to protect Lender's interests. All expenses incurred or paid by Lender for such purposes will then beer interest at the rate charged under the Credit Agreement, or the maximum rate permitted by law, whichever is less, from the date incurred or paid by Lender to the date of repayment by Grantor. All such expenses will become a part of the Indebtedness and, at Lender's option, will. (A) be payable on demand.

(B) be added to the bitlance of the Credit Agreement and be apportioned among and be payable with any installment payments to become due during either. (1) the term of any applicable insurance policy; or. (2) the remaining term of the Credit Agreement; or. (C) be treated as a belicon payment which will be due and payable at the Credit Agreement's maturity. The Property also will secure payment of these amounts. The rights provided for in this paragraph shall be in addition to any other rights or any remades to which Lender may be entitled on account of any default. Any such action by Lender shall not be construed as curing the default so as to bar Lender from any remedy that it otherwise would have had.

WARRANTY; DEFENSE OF TITLE. The following provisions relating to ownership of the Property are a part of this Mortgage:

Title. Grantor warrants that: (a) Grantor holds good and markstable title of record to the Property in fee simple, free and clear of all tiens and encumbrances other than those set forth in the Real Property description or in any title insurance policy, title report, or final title opinion essent in tayor of, and accepted by, Lender in conrection with this Microgape, and (b) Grantor has the full right, power, and authority to execute and deliver this Mortgage to Lender.

Defense of Title. Subject to the exception in the paragraph above, Grantor warrants and will forever defend the title to the Property against the lawful claims of all persons. In the event any action or presenting is commenced that questions Grantor's title or the interest of Lander under this Mortgage, Grantor shall defend the action at Grantor's expense. Grantor may be the nominal party in such proceeding, but Lander shall be entitled to participate in the proceeding and to be represented in the proceeding by counsel of Lander's own choice, and Grantor will deliver, or cause to be delivered, to Lander such instruments as Lander may request from time to time to permit such participation.

Compliance With Laws. Grantor warrants that the Property and Grantor's use of the Property complies with all existing applicable laws, ordinances, and regulations of governmental sulhorities.

CONDENNATION. The following provisions relating to condemnation proceedings are a part of this Mortgage:

Proceedings. If any proceeding in condemnation is fied, Grantor shall promptly notify Lender in writing, and Grantor shall promptly take such

Times. The following shall constitute taxes to which this section applies: {1} a specific tax upon this type of Mortgage or upon all or any part of the Indebtedness secured by this Mortgage; {2} is specific tax on Grantor which Grantor is authorized or required to deduct from payments on the Indebtedness secured by this type of Mortgage; {3} at tax on this type of Mortgage chargeable against the Lender or the holder of the Credit Agreement; and {4} is specific tax on all or any portion of the Indebtedness or on payments of principal and interest made by Grantor

Subsequent Tames. If any tex to which this section applies is enacted subsequent to the date of this Mortgage, this event shall have the same effect as air Event of Default, and Lender may exercise any or all of its available remedies for an Event of Default as provided below unless Grantor either (1) pays the tax before it becomes delinquent, or (2) contests the tax as provided above in the Taxes and Liens section and deposits with Lender cash or a sufficient corporate surety bond or other security satisfactory to Lender.

SECURITY AGREEMENT; FINANCING STATEMENTS. The following provisions relating to this Mortgage as a security agreement are a part of this Mortgage:

Security Agreement. This instrument shall constitute a Security Agreement to the extent any of the Property constitutes fixtures or other personal property, and Lander shall have all of the rights of a secured party under the Uniform Commercial Code as amended from time to time.

Security Interest. Upon request by Lender, Grantor shall execute financing statements and take whatever other action is requested by Lender to perfect and continue Lender's security interest in the Personal Property. In addition to recording this Mortgage in the real property records, Lender may, at any time and without further authorization from Grantor, file executed counterparts, copies or reproductions of this Mortgage as a financing statement. Grantor shall reimburse Lender for all experiess incurred in perfecting or continuing this security interest. Upon default, Grantor shall assemble the Personal Property in a manner and at a piece reasonably convenient to Grantor and Lender and make it available to Lender within three (3) days after receipt of written demand from Lender.

Addresses. The mailing addresses of Grantion (debtor) and Landar (secured party) from which information concerning the security interest granted by this Mortgage may be obtained (each as required by the Uniform Commercial Code) are as stated on the first page of this Mortgage.

FURTHER ASSURANCES; ATTORNEY-IN-FACT. The following provisions relating to further assurances and attorney-in-fact are a part of this Mortgage:

Purifier Assurances. At any time, and from time to time, upon request of Lender, Grantor will make, execute and deliver, or will cause to be made, executed or delivered, to Lender or to Lender's designes, and when requested by Lender, cause to be filed, recorded, refiled, or rerecorded, as the cause may be, at such times and in such offices and places as Lender may deem appropriate, any and all such mortgages, deeds of trust, security deeds, security agreements, financing statements, continuation statements, instruments of further assurance, certificates, and other documents as may, in the sole opinion of Lander, be necessary or desirable in order to effectuate, complete, perfect, continue, or preserve. (1). Grantor's obligations under the Credit Agreement, this Mortgage, and the Related Documents, and. (2). The tens and security interests created by this Mortgage on the Property, whether now owned or hereafter acquired by Grantor. Unless prohibited by law or Lender agrees to the contrary in writing, Grantor shalt relimburse Lender for all costs and expenses incurred in connection with the matters referred to in this paragraph.

Attorney-in-Fact. If Grantor fails to do any of the things referred to in the preceding paregraph, Lender may do so for and in the name of Grantor and all Grantor's expense. For such purposes, Grantor hereby irrevocably appoints Lender as Grantor's attorney-in-fact for the purpose of making, executing, delivering, fling, recording, and doing all other things as may be necessary or desirable, in Lender's sole opinion, to accomplish the matters referred to in the preceding paracraph.

FULL PERFORMANCE. If Grantor pays all the indebtedness when due, terminates the credit line account by notifying Lender as provided in the Credit Agreement, and otherwise performs all the obligations imposed upon Grantor under this Mortgage, Lender shall execute and deliver to Grantor a suitable splittedion of this Mortgage and suitable statements of termination of any financing statement on file evidencing Lender's security interest in the Flerits and the Personal Property. Grantor will pay, if permitted by applicable law, any reasonable termination fee as determined by Lender from time to time.

EVENTS OF DEFAULT. Grantor will be in default under this Mortgage if any of the following happen:

- (1) Grantor commits traud or makes a majorial misrepresentation at any time in connection with the Credit Agreement. This can include, for example, a false statement about Grantor's income, assets, liabilities, or any other aspects of Grantor's financial condition.
  - (2) Granfor does not meet the repayment terms of the Credit Agreement.
- (3) Grantor's action or inaction adversely effects the polleteral or Lander's rights in the colleteral. This can include, for example, failure to maintain required insurance, waste or destructive use of the dwelling, failure to pay texas, death of all persons liable on the account, transfer of side or sale of the dwelling, creation of a senior lien on the dwelling without our permission, foreclosure by the holder of another lien, or the use of funds or the dwelling for prohibited purposes.

RIGHTS AND REMEDIES ON DEFAULT. Upon the occurrence of an Event of Default and at any time thereafter, Lender, at Lender's option, may exercise any one or more of the following rights and remedies, in addition to any other rights or remedies provided by law:

Accelerate indebtedness. Lender shall have the right at its option without notice to Granfor to declare the entire indebtedness immediately due and payable, including any prepayment penalty which Grantipr would be required to pay.

UCC Remedies. With respect to all or any part of the Personal Property, Landar shall have all the rights and remedies of a secured party under the Uniform Commercial Code.

Collect Rents. Lander shall have the right, without notice to Grantor, to take possission of the Property and collect the Rents, including amounts past due and unpaid, and apply the net proceeds, over and above Lender's costs, against the Indebtedness. In furtherance of this right, Lender may require any tenant or other user of the Property to make playments of rent or use less directly to Lender. If the Rents are collected by Lender, then Grantor irrevocably designates Lender as Grantor's althoray-in-lect to endorse instruments received in payment thereof in the name of Grantor and to negotiate the same and collect the proceeds. Payments by tenants or other users to Lender in response to Lender's demand shall salisty the obligations for which the payments are made, whether or not any proper grounds for the demand assisted. Lender may exercise its rights under this subparagraph either in person, by agent, or through a receiver.

Appoint Receiver. Lender shall have the right to have a niceiver appointed to take possession of all or any part of the Property, with the power to protect and preserve the Property, to operate the Property preceding foreclosure or sale, and to collect the Rents from the Property and apply the proceeds, over and above the cost of the receivership, against the Indebtedness. The receiver may serve without bond if permitted by lew. Lander's right to the appointment of a receiver shall exalt whatther or not the apparent value of the Property exceeds the Indebtedness by a substantial amount. Employment by Lender's field not disqualify a person from serving as a receiver.

Judicial Forectoeure. Lender may obtain a judicial decree terestosing Grantor's interest in all or any part of the Property.

Nonjudicial Sale. Lender will be authorized to take possession of the Property and, with or without taking such possession, after giving notice of the time, place and terms of sale, together with a description of the Property to be sold, by publication once a week for three (3) successive weeks in some newspaper published in the county or counties in which the Real Property to be sold is located, to sail the Property (or such part or parts
