**KNOW ALL MEN BY THESE PRESENTS**, that in consideration of the sum of Ninety-Nine Thousand Nine Hundred Seventy-Five and No/100 Dollars (\$99,975.00) the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged **OLD SOUTH BUILDERS, INC.**, (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto **EDILITA M. HOBBY & BRIAN K. HOBBY**, (herein referred to as "Grantee"), as joint tenants with rights of survivorship, the following described real estate situated in Shelby County, Alabama, to wit:

Lot 136, according to the Survey of Camden Cove, Sector 1, as recorded in Map Book 25, Page 33 A, B & C, in the Probate Office of Shelby County, Alabama
