

**CORPORATION FORM WARRANTY DEED
JOINT TENANTS WITH RIGHT OF SURVIVORSHIP**

Wilkins Construction, Inc., in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, the said Grantor does by these presents, grant, bargain, sell and convey unto Ralph Kenneth Smith and Wife, Jeanne Barbara Smith (herein referred to as Grantees) as joint tenants with right of survivorship, the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 6, according to the Survey of "Bunglows" of Old Town, as recorded in Map Book 25, Page 16 in the Probate Office of Shelby County, Alabama.

Described property to become the homestead of Grantees.
