SPECIFIC POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, that I, STEPHEN J. THAMES, a legal resident of the State of Alabama, have this day made, constituted and appointed and by these presents have made, constituted and appointed MARY BOCKETT my true and lawful attorney in fact, and my power is set as follows:

GIVING AND GRANTING unto my said attorney in fact full power to execute all documents necessary to close a real estate transaction for real property located at 1405 Salsmanter Drive, Helena, Alabama 35890, with a legal description as follows:

Lot 41, according to the Survey of Dearing Downs, 6th Add., Phase II, Final Plat, as recorded in Map Book 11, Page 31 and refiled in Map Book 11, page 80, in the Office of the Judge of Probate of Shelby County, Alabama.

This Specific Power of Attorney shall be used in accordance with that certain real estate transaction wherein Stephen J. Thames and wife Misti L. AND I HEREBY DECLARE that any act or thing lawfully done hereunder by my said attorney in fact shall be binding on myself and my heirs, legal representatives and assigns.

PROVIDED HOWEVER, that all business transacted hereunder for me or for my account shall be transacted in my name, and that all endorsements and instruments executed by my said attorney in fact for the purpose of carrying out the foregoing powers shall contain my name, followed by that of my said attorney in fact and the designation "attorney in fact."

FURTHER, this power of attorney shall remain in full force and effect until the occurrence of the first of the following circumstances: (1) my death; (2) the death of my said attorney in fact; (3) until the revocation of this power of attorney; or (4) ninety days from the date of closing of the transaction referred to herein to conclude the sale of the herein described and referenced property.
