KNOW ALL MEN BY THESE PRESENTS,

That in consideration of ONE HUNDRED AND NO/100 DOLLARS (\$100.00), AND THE PURPOSE OF CREATING SURVIVORSHIP TITLE, to the undersigned Grantors in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, RICHARD L. TINNELL AND WIFE KELLIE TINNELL, (herein referred to as Grantors) do grant, bargain, sell and convey unto RICHARD L. TINNELL AND KELLIE TINNELL (herein referred to as Grantees), as joint tenants, with right of survivorship, the following described real estate, situated in the State of Alabama, County of SHELBY, to-wit:
