This EASEMENT, executed this 30th day of Nov, 1999, for the construction, operation, and maintenance of utility lines, with appurtenances, by the City of Calera and the Calera Water Board, hereinafter called collectively the OWNER, across the property of the LANDOWNER, A. C. Legg Inc., as shown on the attached sketch, is granted by the LANDOWNER to the OWNER for valuable considerations, the receipt and sufficiency of which are acknowledged by the LANDOWNER, for himself, and his heirs, executors, successors, and assigns.

A permanent easement, to go with land, to allow the OWNER, its employees and agents to construct, operate, repair, and maintain the OWNER'S utility lines, including the right of access by the OWNER, its employees and agents, or officials, and necessary related equipment. Included is the right to uncover the utility lines, with the obligation to leave the LANDOWNER'S property in good repair after completion of construction or repair to the utility lines.

The easement is described, as follows:

A 30 foot easement, parallel, and adjacent with the Eastern property line of the LANDOWNER'S property, said property line being the Western R.O.W. of U.S. 31, as shown on the attached sketch.

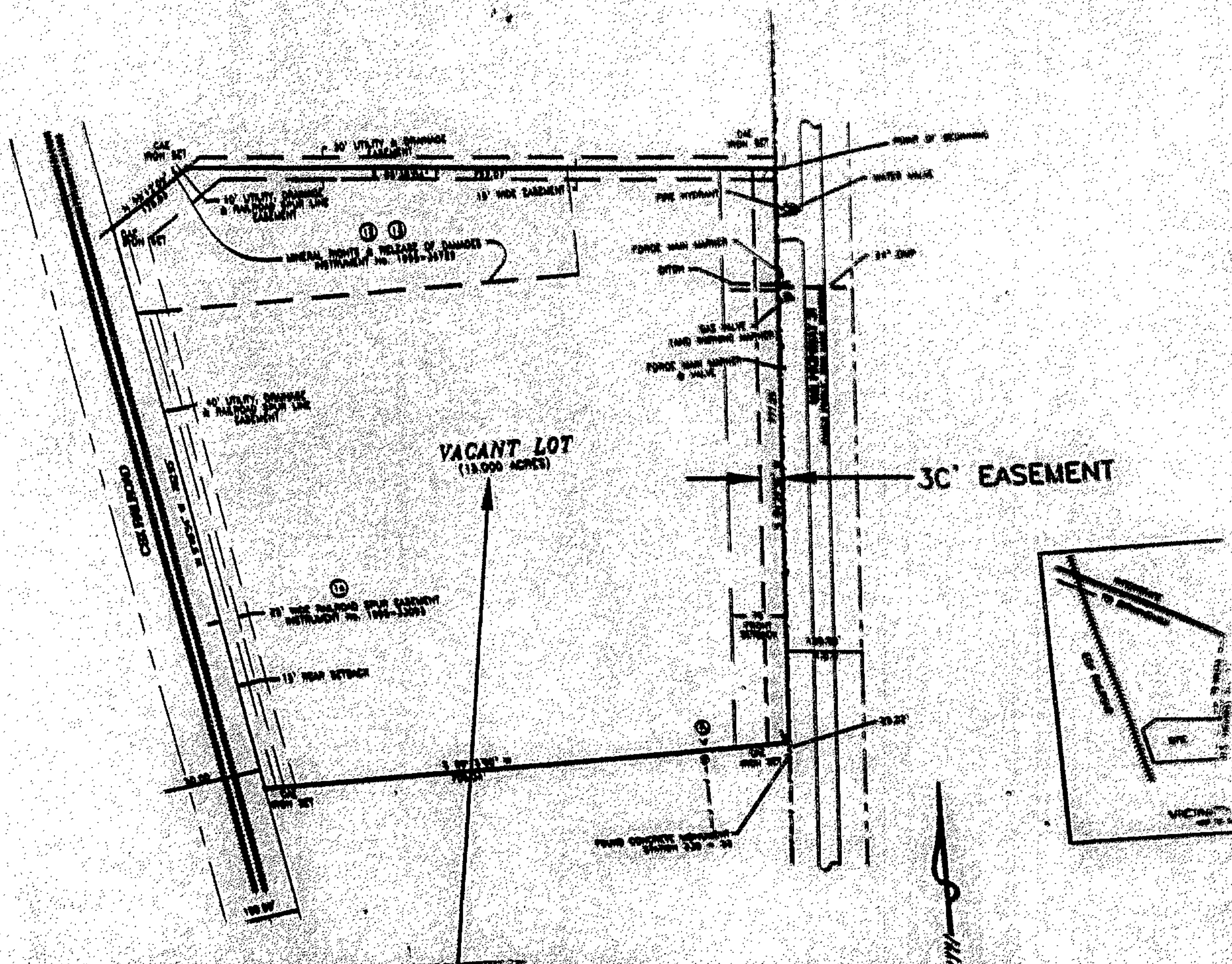
