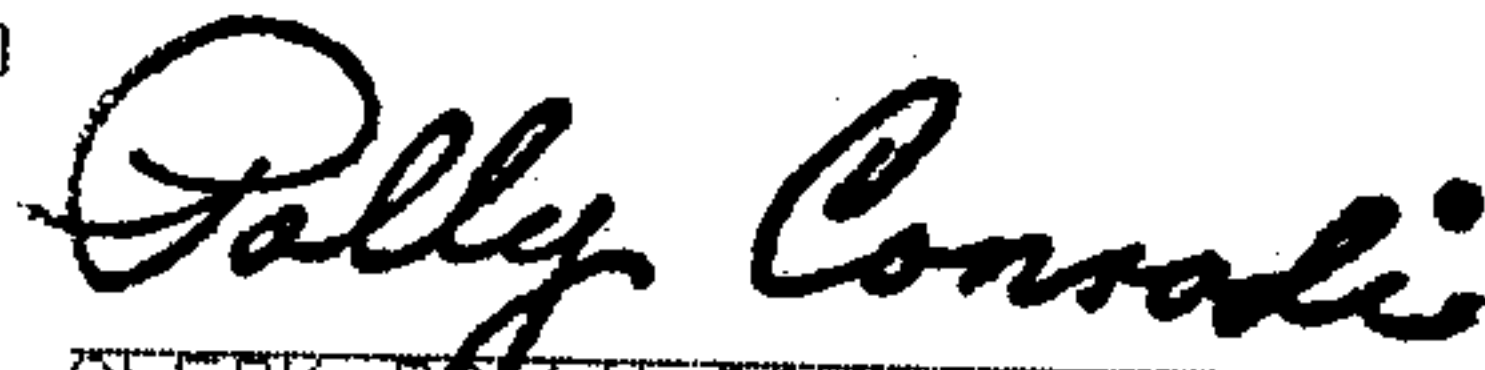

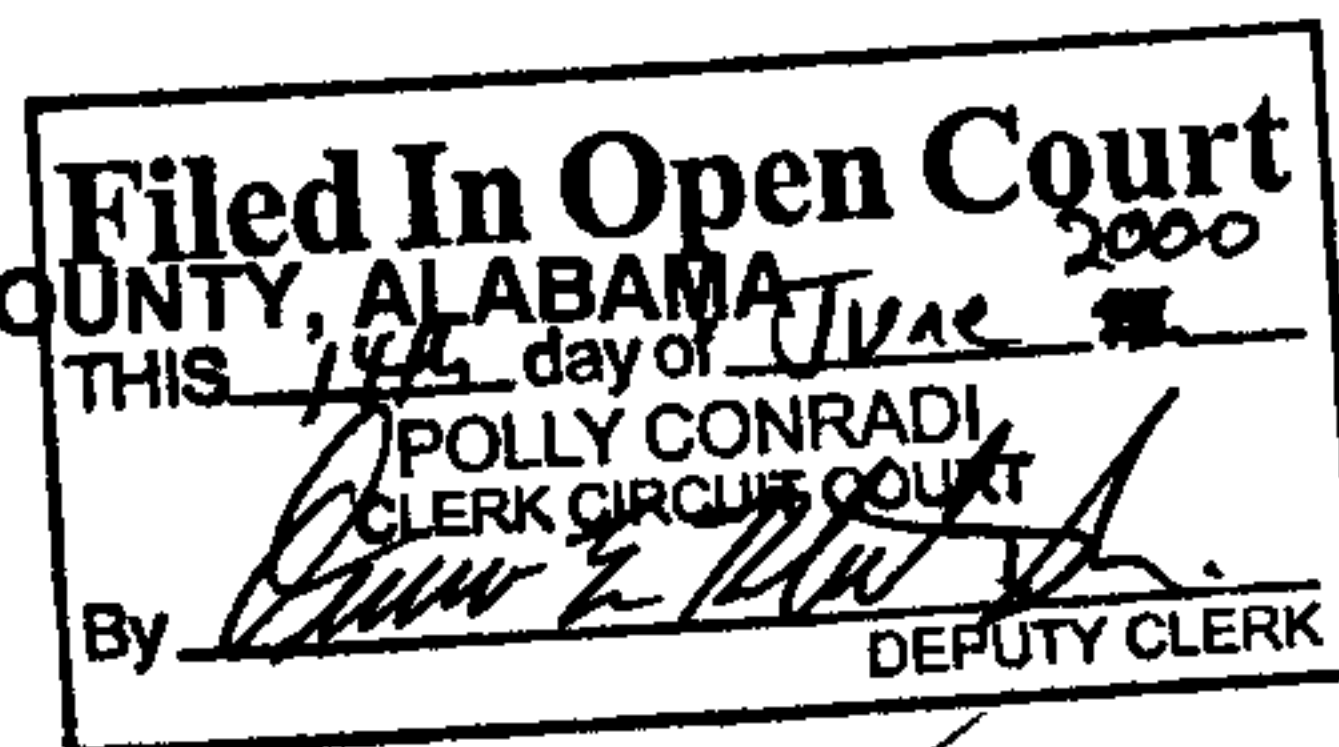

FINAL ORDER

This matter was submitted to Court on the Plaintiff's Motion for Default Judgment and Order of Default against the Defendants, Kevin Loggins, and Stacie B. Paullin. The Court having considered the Application for Default Judgment, the Order of Default, and the Affidavit of the Plaintiff, finds that relief is due to be **GRANTED**. It is therefore **ORDERED** as follows:

1. That a Monetary Judgment is hereby in favor of the Plaintiff, Garrison Construction Co., Inc., and against the Defendants, Kevin Loggins, and Stacie B. Paullin, for the sums of Thirty-Four Thousand Four Hundred Eighty-Four Dollars and 92/100ths (\$34,484.92). That said Judgment consists of the sum of Thirty-Two Thousand Five Hundred Thirty-Three Dollars (\$32,533.00) due April 16, 1999, and 6% interest from April 16, 1999, to date of Nineteen Hundred Fifty-One Dollars and 92/100ths (\$1,951.92) for a total of Thirty-Four Thousand Four Hundred Eight-Four Dollars and 92/100ths (\$34,484.92).
2. Costs taxed to the Defendants.
