
**IN THE MATTER OF BUELAH CAFFEY,**

RE: Family Cemetery - Simsville Area

To Whom It May Concern:

As per a request by Mrs. Beaula Caffey through Mr. Robert Kelly, this office made several site visits to the above referenced area. An approximate two acre site was carefully evaluated to determine an approvable area for burial. In accordance with "Public Health Laws of Alabama" 22-20-4, a number of factors are used to determine those sites. The findings are as follows:

1. The north northeast portion of the property should not be used because of steepness of slope.
2. The north northwest portion of the property should not be used because of surface drainage and steepness of slope.
3. The "center" portion of the acreage, adjacent to and east of the Liberty Church cemetery met all requirements as set forth by the State of Alabama and the Shelby County Health Department. A ten foot soil bore was dug. After two consecutive days of checking, it was confirmed that there would be no contamination of the ground water aquifer.

With all facts considered, this office recommends approval of the site as requested by Mrs. Beaula Caffey for a "Family Cemetery".

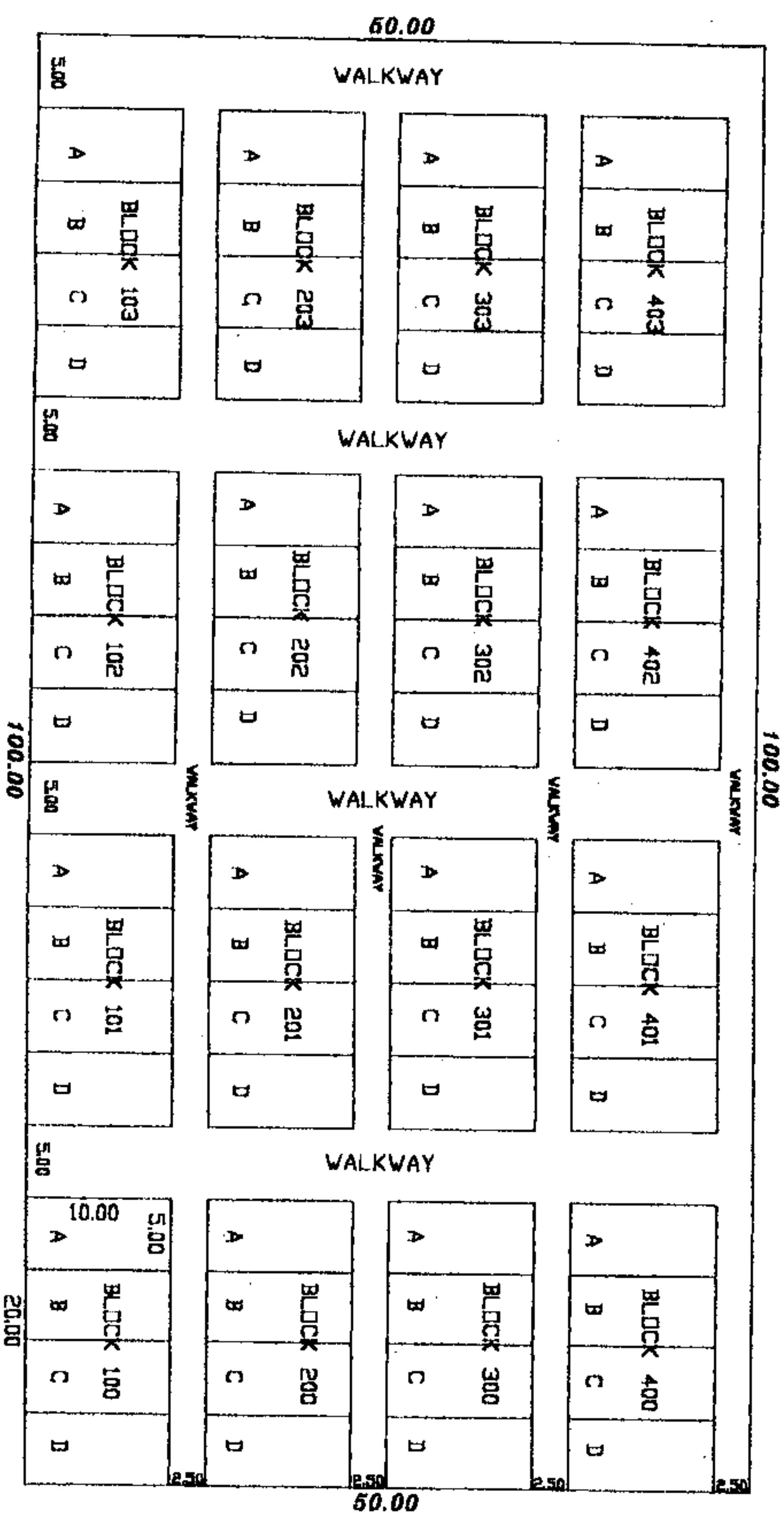
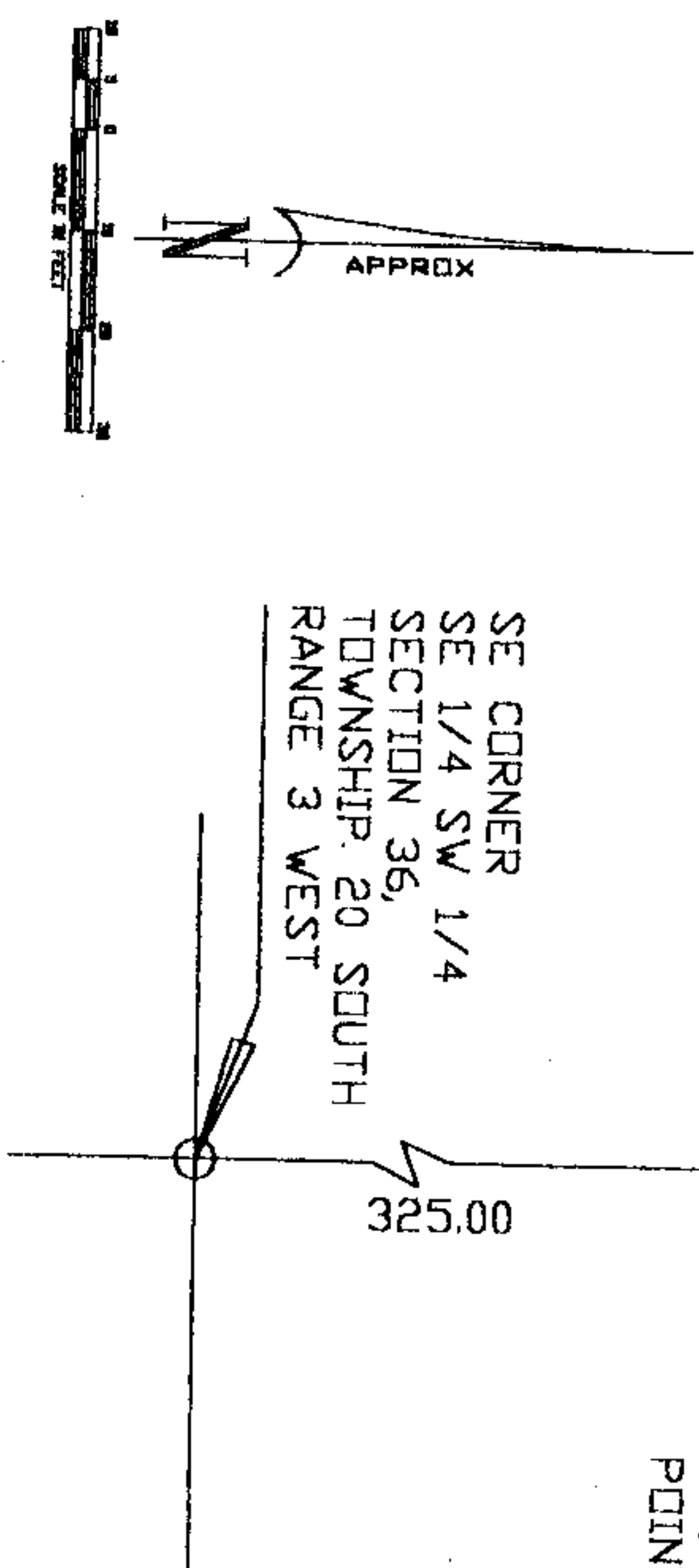

COMMENCE AT THE SE CORNER OF THE SE 1/4 OF THE SW 1/4 OF SECTION 36, TOWNSHIP 20 SOUTH, RANGE 3 WEST, SHELBY COUNTY ALABAMA AND RUN NORTH ALONG THE EAST LINE OF SAID 1/4 1/4 SECTION FOR A DISTANCE OF 325.00 FEET TO THE POINT OF BEGINNING; THENCE CONTINUE ALONG LAST DESCRIBED COURSE FOR A DISTANCE OF 50.00 FEET; THENCE WESTERLY AND PARALLEL TO THE SOUTH LINE OF SAID 1/4 1/4 SECTION FOR A DISTANCE OF 100.00; THENCE SOUTHERLY AND PARALLEL TO THE EAST LINE OF SAID 1/4 1/4 SECTION FOR A DISTANCE OF 50.00 FEET; THENCE EASTERLY AND PARALLEL TO THE SOUTH LINE OF SAID 1/4 1/4 SECTION FOR A DISTANCE OF 100.00 FEET TO POINT OF BEGINNING.
