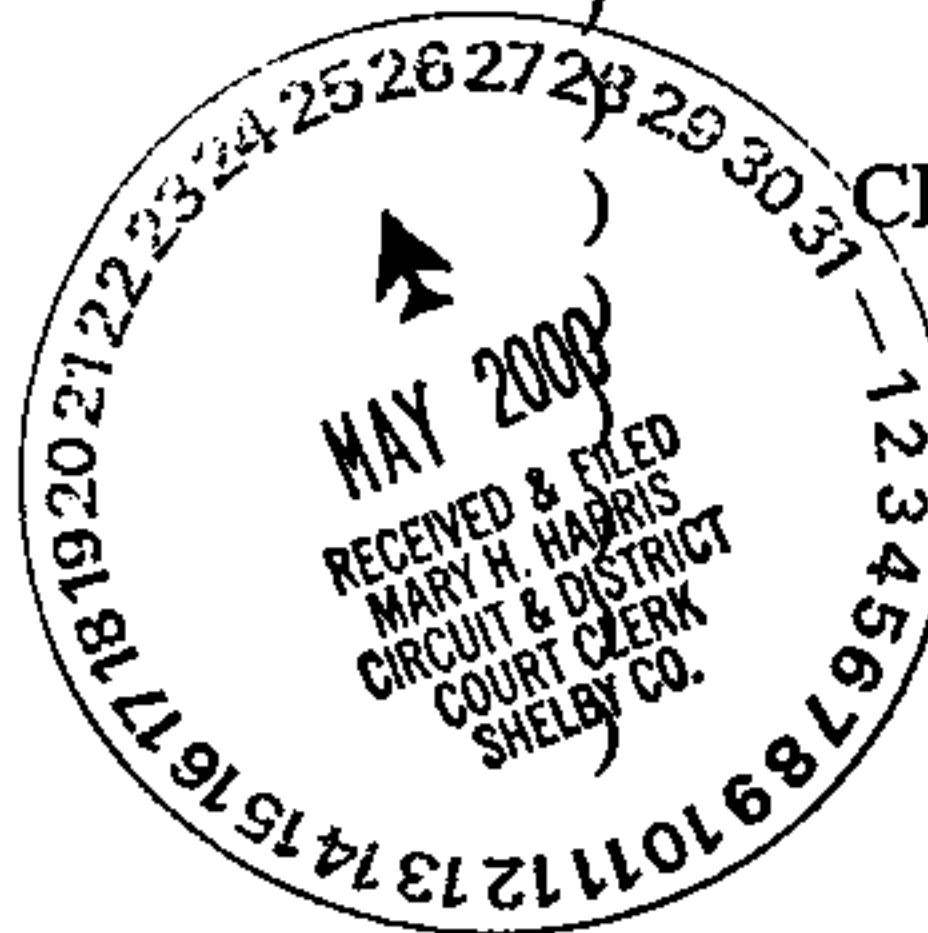

ENTRY OF JUDGMENT

ON THIS 25th day of MAY, 2000, this cause came to be heard on Plaintiff's Motion for Default Judgment against Defendant Faithway Homes, Inc. The Court, having considered the affidavit of the Plaintiff's attorney and the affidavit of Andrew B. Brown III, President of the Plaintiff, concerning the lien claimed by the Plaintiff in the amount of the indebtedness, and upon consideration of the evidence produced, the Court finds the Plaintiff is entitled to \$27,551.31, plus interest and costs and to a lien for said amount against the following described property situated in Shelby County, Alabama, to-wit:
