Meadows and wife, Angela Lorino Meadows,** (hereinafter referred to as GRANTORS), in hand paid by the GRANTEES herein, the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEES, **Donald M. Meadows and Angela L. Meadows,** (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of **Shelby**, State of Alabama, to-wit:

Lot 2, according to the Survey of Lorino-Meadows Family Subdivision, as recorded in Map Book 27, Page 30, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.

\$203,500.00 of the consideration was paid from the proceeds of a mortgage loan closed simultaneously herewith.


