**KNOW ALL MEN BY THESE PRESENTS:** That in consideration of Thirty-eight thousand Four Hundred and No/100 Dollars (\$38,400.00), to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, M. A. Kearns, UN married, dba Malak Construction Company herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto K. and H. Construction, LLC, an Alabama limited liability company (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 43 according to the survey of Meadow Brook Cluster Homes, second sector as recorded in Map Book 22, Page 110, Probate Office of Shelby County, Alabama.
