KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of One Hundred Thirty Thousand Five Hundred and 00/100 (\$130,500.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR, **Keystone Building Company, Inc., a corporation** (hereinafter referred to as GRANTOR), the receipt whereof is hereby acknowledged, the GRANTOR does hereby give, grant, bargain, sell and convey unto the GRANTEES, **Stanley V. Vines and Ethel C. Vines, husband and wife**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of SHELBY, State of Alabama, to-wit:

Lot 225, according to the Survey of The Glen at Stonehaven, as recorded in Map Book 26, Page 91, in the Probate Office of Shelby County, Alabama.

\$70,500.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.

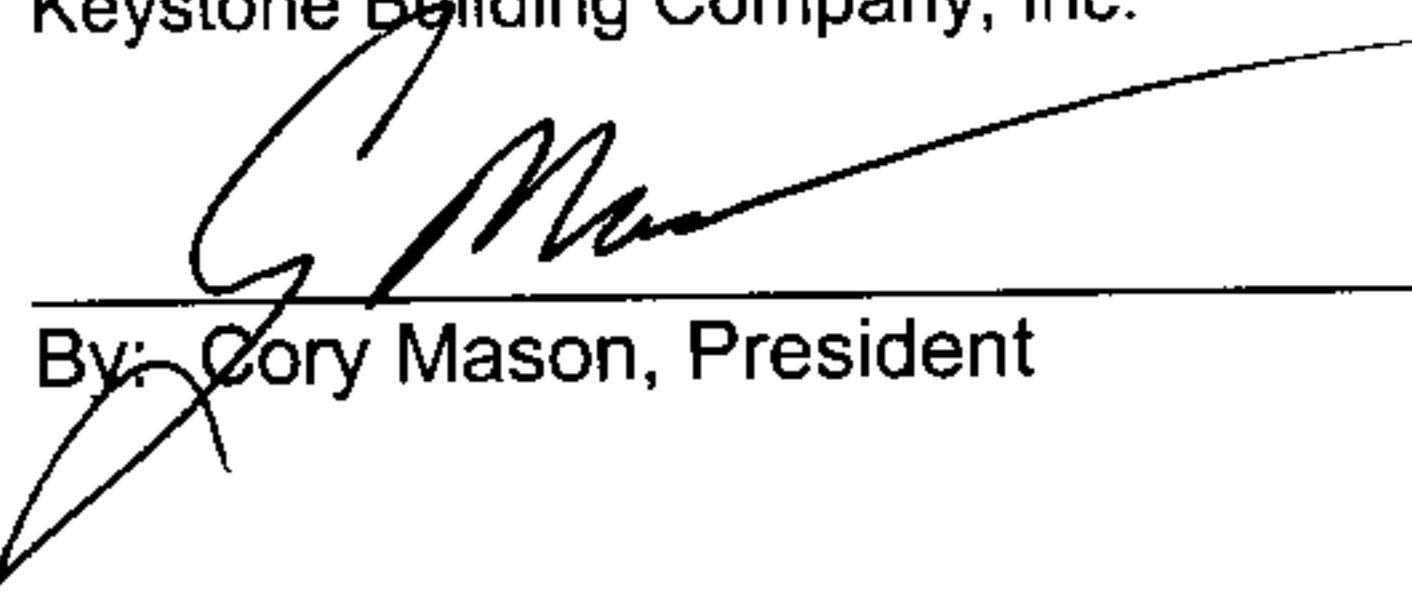
Keystone Building Company Inc. and Keystone Building Co., Inc. are one and the same entity.

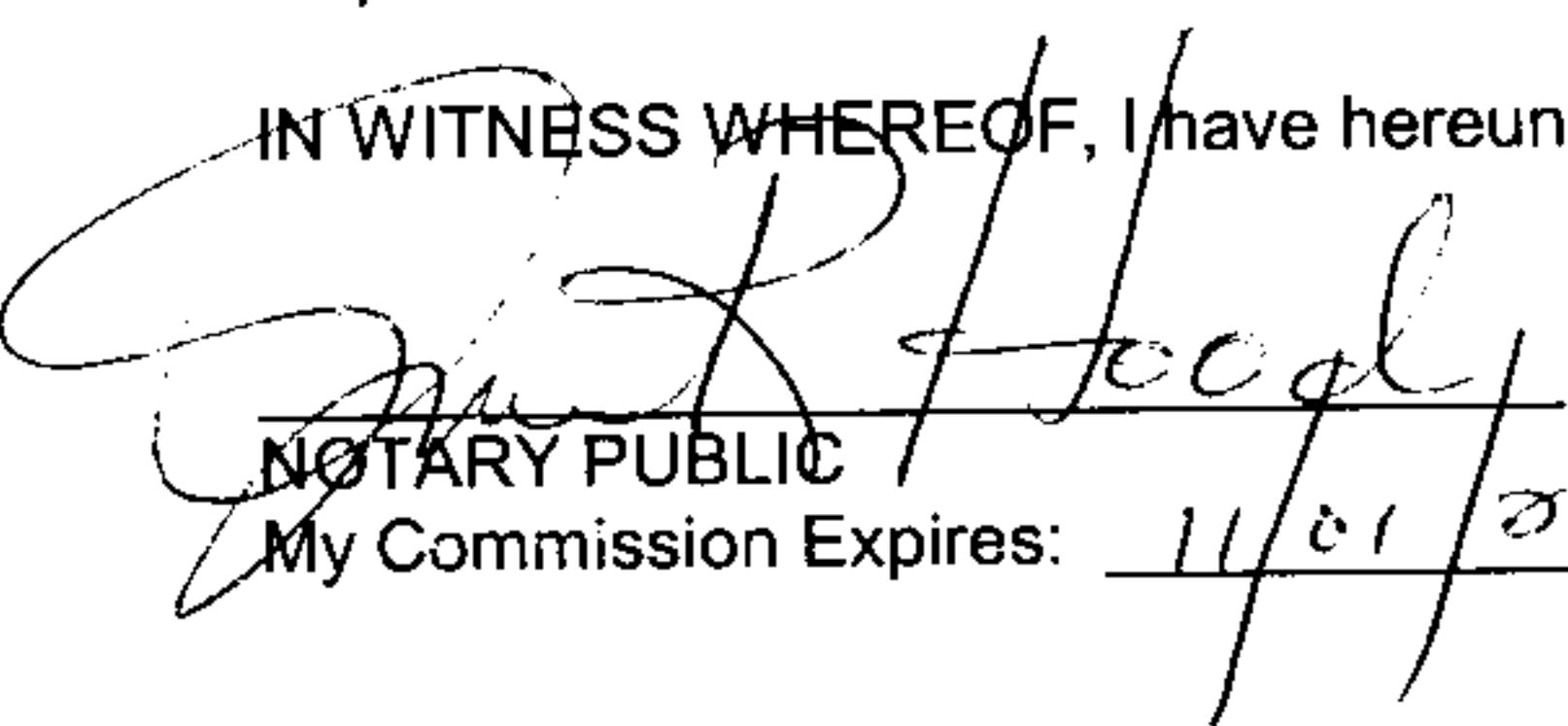
