SUBSTITUTION OF MORTGAGE COLLATERAL

The undersigned, Professional Homebuilders, Inc., a corporation, does further agree and obligate said lands to all the terms and conditions of the aforescribed promissory note dated November 21, 1997, in the amount of \$100,000.00 as the same is secured by the aforescribed

mortgage and does acknowledge that with the exception of this substitution of collateral as security under said mortgage, the other terms and conditions of said promissory note and mortgage remain the same and unchanged.

The undersigned, Professional Homebuilders, Inc., a corporation, makes this substitution of collateral with the understanding that certain collateral, as agreed to by and between them and Colonial bank is being simultaneously released so that they may sell or dispose of or otherwise convey the same.
