A tract of land situated in the southeast 1/4 of Section 7 and the southwest 1/4 of Section 8, Township 19 South, Range 1 West, Shelby County, Alabama, being more particularly describe as follows: begin at the southeast corner of said Section 7 and run westerly along the south line of said Section 7 a distance of 1,325.79 feet; thence turn 91 degrees 15 feet and 10 inches right and run northerly for 1,257.87 feet; thence turn 149 degrees 39 feet 27 inches right and run southeasterly for 287.37 feet; thence turn 12 degrees 42 feet 9 inches left and run southeasterly for 462.89 feet; thence turn 28 degrees 22 feet 15 inches left and run southeasterly for 768.09 feet; thence turn 19 degrees 16 feet 50 inches left and run easterly for 188.04 feet; thence turn 37 degrees 3 feet 8 inches right and run southeasterly for 210.37 feet; thence turn 74 degrees 23 feet 48 inches right and run southwesterly for 297.04 feet to a point on the south line of said Section 8; thence turn 70 degrees 25 feet 44 inches right and run 115.91 feet to the point of beginning, containing 21.41 acres.
