## **MEMORANDUM OF LEASE**

This Memorandum of Lease ("Memorandum") is executed and entered into effective as of May 15, 2000, by and between Allcomm Wireless, Inc., (hereinafter referred to as "Lessor," whether one or more) and Southern Communications Services, Inc. d/b/a Southern LINC (hereinafter referred to as "Lessee").

## RECITALS:

Lessor and Lessee are parties to that certain Lease Agreement dated on or about May 15, 2000 (the "Agreement") pursuant to which Lessor granted to Lessee the right to lease certain space on Lessor's communications tower (the "Tower Facilities") located on a certain tract or parcel of land (the "Land") described as Shelby County, Alabama (said Tower Facilities and Land hereinafter called "Premises") together with related easements.

- 2.1 The name of the Lessor is as set forth above.
- 2.2 The name of the Lessee is Southern Communications Services, Inc. d/b/a Southern LINC.
- 2.3 The initial term ("Initial Term") of the Lease shall expire on or about May 14, 2005.
- The Lease grants to the Lessee the option to extend the Lease for four (4) additional periods of five (5) years (each an "Extension Term").
