KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of One Hundred Thirty-Eight Thousand and 00/100 (\$138,000.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTORS, **Kenneth H. Breal and Toyanna C. Breal, husband and wife** (hereinafter referred to as GRANTORS), the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEES, **Timothy S. Pettibone and Michele B. Pettibone, husband and wife**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of SHELBY, State of Alabama, to-wit:

Lot 27, according to the Survey of an Amended Map of Dearing Downs, 5th Sector, as recorded in Map Book 10 page 71 in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.



Subject to existing easements, current taxes, restrictions and covenants, set-back lines and rights of way, if any, of record.


