ASSIGNMENT OF MORTGAGE

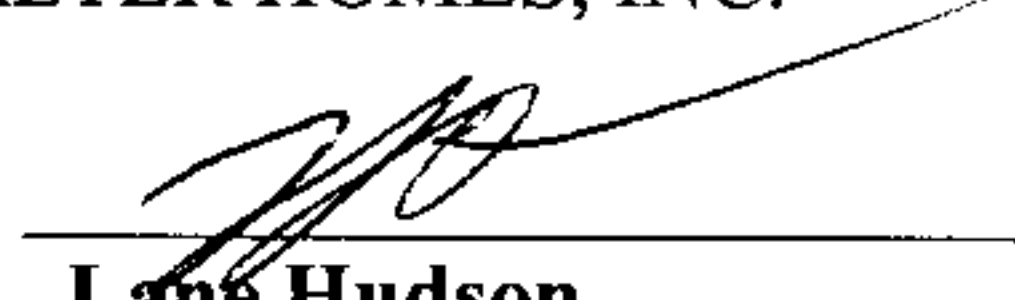

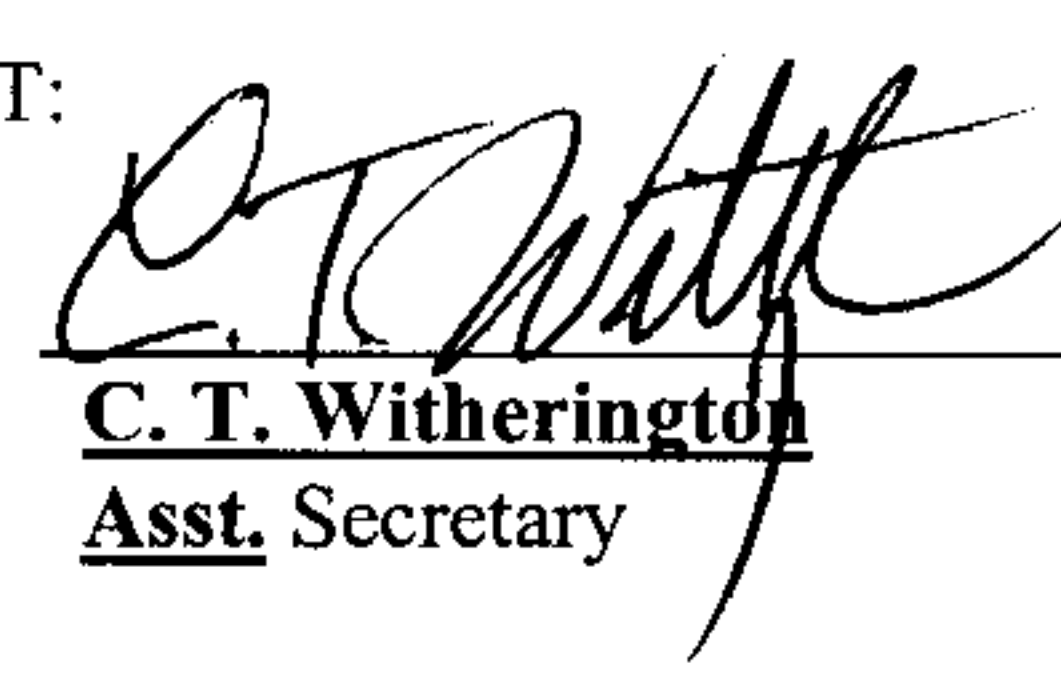

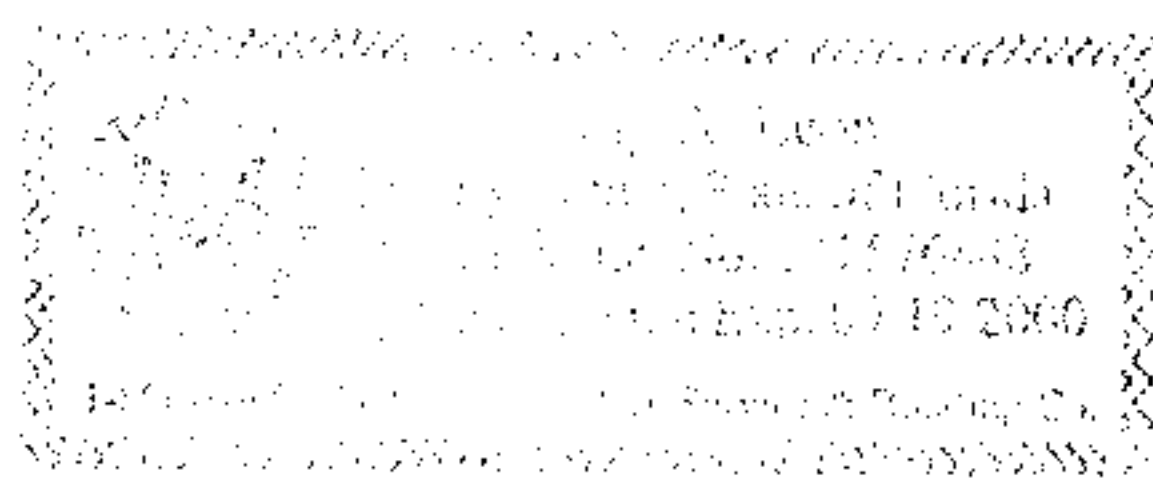
