

EXHIBIT "A"

A Parcel of Land situated in the Northwest quarter of the Northeast quarter of Section 7, Township 21 South, Range 1 West, Shelby County, Alabama, being more particularly described as follows:

Commence at an axle found locally accepted to be the Northeast corner of said Section 7; thence run South 88 degrees, 47 minutes, 00 seconds West along the North line of said Section 7 for a distance of 1,330.52 feet to a 4" X 4" concrete monument found locally accepted to be the Northeast corner of the Northwest quarter of the Northeast quarter of said Section 7; thence run South 88 degrees, 19 minutes, 29 seconds West for a distance of 1317.36 feet to a 4" X 4" concrete monument found locally accepted to be the Northwest corner of said quarter-quarter section; thence run East along the North line of said quarter-quarter section for a distance of 1,219.27 feet to an iron pin set at the point of beginning 98.09 feet West of a 4" X 4" concrete monument found. Said iron pin set being on a curve to the right having a central angle of 03 degrees, 14 minutes, 59 seconds and a radius of 3,178.65 feet; thence turn an interior angle to the left to the cord of said curve of 120 degrees, 13 minutes, 16 seconds and run in a Southeasterly direction along the arc of said curve for a distance of 180.77 feet North of a 3/4 " rebar found; thence turn an angle from the chord of last stated curve to the left of 147 degrees, 04 minutes, 20 seconds and run in a Northerly direction along the East line of said quarter-quarter section for distance of 155.93 feet to a 4" X 4" concrete monument found; ; thence turn an angle to the left of 92 degrees, 42 minutes, 24 seconds and run West along the North line of said quarter-quarter section for a distance of 98.09 feet to the point of beginning.
