**FIRST AMENDMENT TO FUTURE ADVANCE MORTGAGE**

This First Amendment to Future Advance Mortgage entered into this 8th day of September, 2000, on behalf of Caplash Corporation (the "Mortgagor") in favor of National Bank of Commerce of Birmingham (the "Bank").

A. By Real Estate Mortgage dated March 28, 2000 and recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Inst. #2000/12328 the Mortgagor, granted a mortgage to the Bank to secure indebtedness in the original principal amount of \$261,000.00 (the "Mortgage").

B. The Mortgagor has requested the Bank to extend further credit to the Mortgagor. The Bank has agreed to extend further credit to the Mortgagor on the condition, among others, that the Mortgagor execute and deliver this First Amendment To Future Advance Mortgage.

C. This is a line of credit. The credit is to be advanced by the Bank to the Mortgagor in installments from time to time pursuant to the terms and conditions of the promissory note described below.

Wherefore, premises considered, the parties hereby agree as follows:

1. WHEREAS, Caplash Corporation is justly indebted to the Mortgagee in the amount of Three Hundred One Thousand and no/100----- (\$301,000.00) as evidenced by that certain promissory note dated September 8, 2000 and which has a final maturity date of March 10, 2001.

2. Except as herein modified, the Mortgage shall remain in full force and effect.
