KNOW ALL MEN BY THESE PRESENTS:

That in consideration of TEN DOLLARS AND OTHER GOOD AND VALUABLE CONSIDERATION to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt whereof is acknowledged, I or we,

**MARY E. DAVIES, A MARRIED WOMAN**

(herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto

**JAMES F. DAVIES AND MARY E. DAVIES, TRUSTEES, OR THEIR SUCCESSORS IN TRUST,  
UNDER THE DAVIES LIVING TRUST, DATED AUGUST 31, 2000 AND ANY AMENDMENTS  
THERETO**

(herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

**Lot 17, Resurvey of Lots 14, 15, 16, 17, 18, and 19, Indian Valley, Third Sector, as recorded in Map Book 5, Page 129, in the Office of the Judge of Probate of Shelby County, Alabama. Subject to taxes, restrictions, rights-of-way, exceptions, conditions and easements of record.**

The above described property constitutes the homestead of Grantor and Grantor's spouse, James F. Davies. As evidenced by his signature below, James F. Davies consents to this conveyance.

TO HAVE AND TO HOLD to the said grantee, his, her or their successors and assigns forever.

And I (we) do for myself (ourselves) and for my (our) heirs, executors, and administrators covenant with the said GRANTEE, his, her or their successors and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will and my (our) heirs, executors and administrators shall warrant and defend the same to the said GRANTEE, his, her or their successors and assigns forever, against the lawful claims of all persons.
