Subject to all easements, restrictions, covenants, rights of way of record; taxes for 2000 and of subsequent years not yet due and payable.


\$ 89,650.00 of the purchase price recited herein was paid from the proceeds of a mortgage loan closed simultaneously herewith.

IN WITNESS WHEREOF, the Grantor has signed and sealed this Deed on the 15th day of September, 2000.


