**EXHIBIT A**

A parcel of land situated in the southeast quarter of the northeast quarter of Section 28, Township 18S, Range 1W, Shelby County, Alabama, being more particularly described as follows:

Begin at a 3" capped iron locally accepted to be the northwest corner of said quarter-quarter section; thence run east along the north line of said quarter-quarter section for a distance of 431.72 feet to the northwest corner of Lot 6A in a Resurvey of Lots 5 and 6 Greystone 8<sup>th</sup> Sector, Phase I, as recorded in Map Book 23, Page 15, in the Office of the Judge of Probate, Shelby County, Alabama; thence turn an angle to the right of 155 degrees, 17 minutes, 58 seconds and run in a southwesterly direction along the northwest line of said Lot 6A and Lot 7 in Greystone 8<sup>th</sup> Sector, Phase I as recorded in Map Book 21, page 151 in the Office of the Judge of Probate, Shelby County, Alabama, for a distance of 237.64 feet to a point; thence turn an angle to the left of 35 degrees, 37 minutes, 31 seconds and run in a southwesterly direction along the northwest line of said Lot 7 for a distance of 68.34 feet to a point; thence turn an angle to the right of 101 degrees, 24 minutes, 44 seconds and run in a northwesterly direction for a distance of 241.45 feet to the point of beginning. Said parcel containing 29,522 square footage, more or less.
