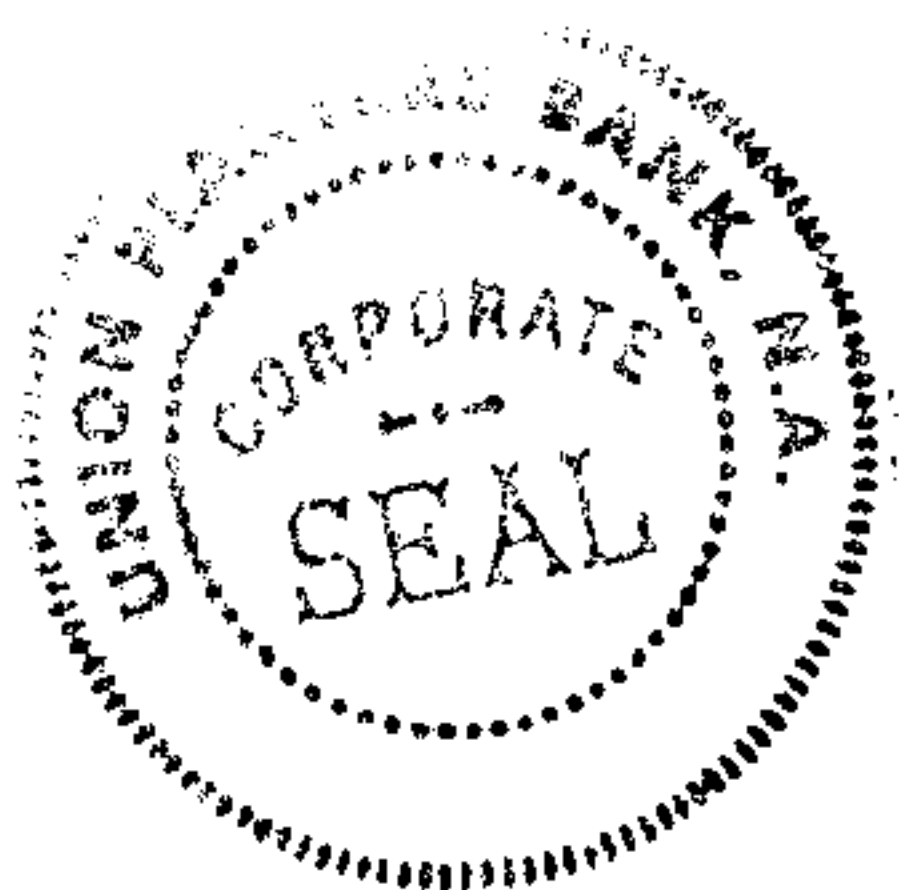
Whereas, on the 14 day of NOVEMBER 1972.

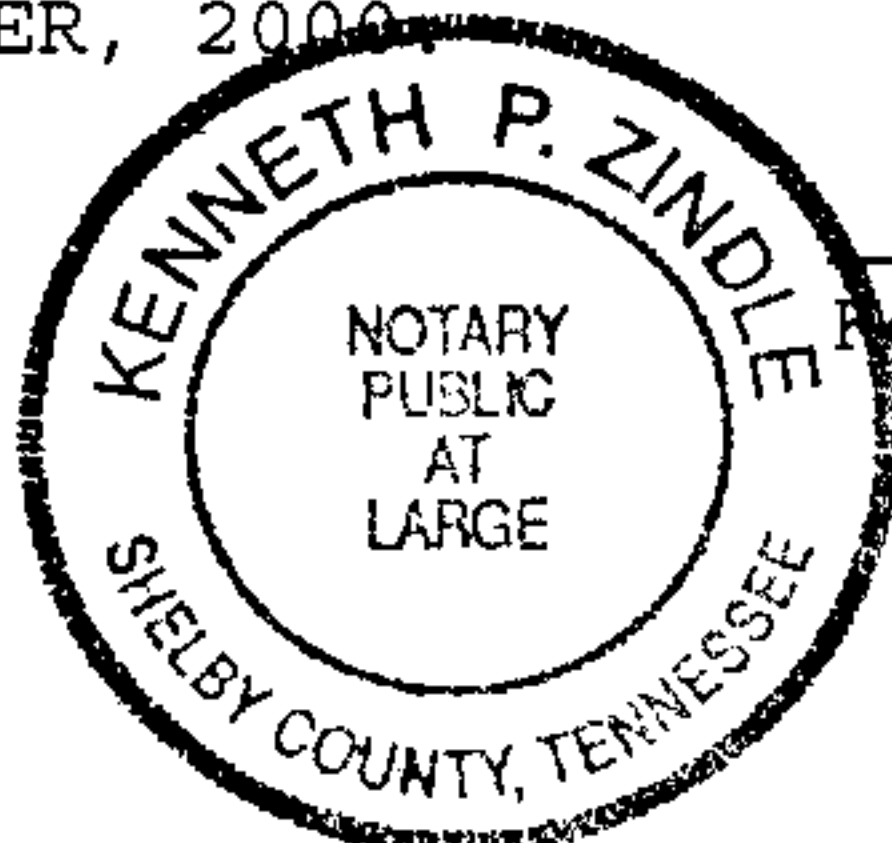
