ORDER OF DEFAULT JUDGMENT


This action came on the application of the plaintiff for entry of default judgment pursuant to Rule 55(b) of the Alabama Rules of Civil Procedure, and the defendants having been duly served with the summons and complaint and not being infants or unrepresented incompetent persons and having failed to plead or otherwise defend, and their default having been duly entered and the defendants having taken no proceedings since such default was entered, accordingly it is

ORDERED and ADJUDGED that judgment is entered in the plaintiff's favor against defendants Mayfield Homebuilders and Susan Mayfield in the amount of \$4261.18, plus interest at the legal rate from July 31, 1999, plus costs, and against defendant Susan Mayfield in the amount of \$2057.61 as attorney's fees and expenses; and it is further

ORDERED and ADJUDGED that liens be imposed on the property located at 4561 South Shades Crest, Bessemer, Alabama, in Jefferson County and at 4564 South Shades Crest, Bessemer, Alabama, in Jefferson County, to secure the payment of the indebtedness of defendants Mayfield Homebuilders and Susan Mayfield to the plaintiff, and, upon the failure to pay the said

indebtedness, said liens will be enforced by the condemnation of said property to sale on such terms and at such a place as is required by law for the payment of the indebtedness owed by defendants to plaintiff.
