KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of Two Hundred Eighty-Eight Thousand Two Hundred and 00/100 Dollars (\$ 288,200.00) to the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged, **NEWCASTLE CONSTRUCTION, INC** (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto **ROBERT B. LIVELY, IV AND LAURA B. LIVELY**, (herein referred to as "Grantee") as joint tenants with rights of survivorship, the following described real estate situated in Shelby County, Alabama, to wit:

Lot 19, according to the Survey of Oak Park Highlands, Sector 3, as recorded in Map Book 26, page 136, in the Probate Office of Shelby County, Alabama.

Subject to all easements, restrictions, covenants, rights of way and covenants of record; taxes for 2000 subsequent years not yet due and payable.

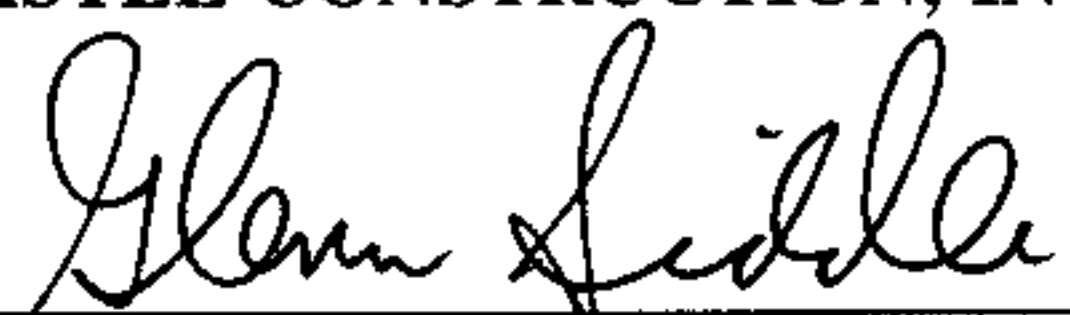
\$230,560.00 of the purchase price recited herein was paid from the proceeds of a mortgage loan closed simultaneously herewith.

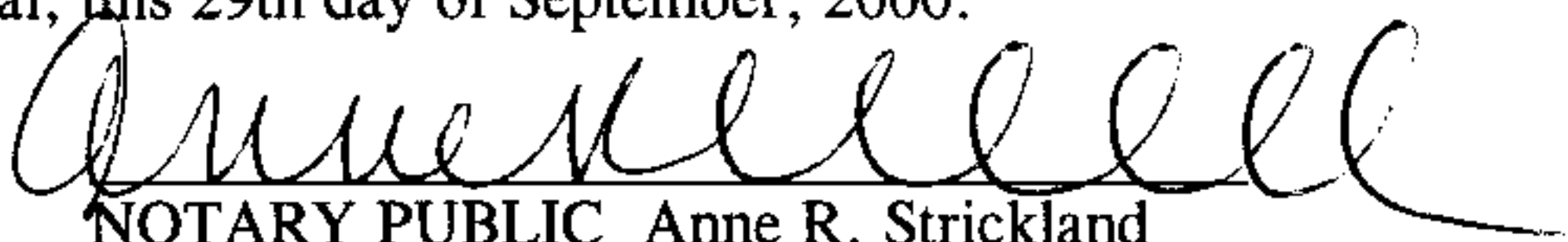
