KNOW ALL MEN BY THESE PRESENTS,

That in consideration of ONE HUNDRED FIFTY SEVEN THOUSAND AND NO/100 DOLLARS (\$157,000.00), to the undersigned Grantors in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, **SAMUEL O. QUATTLEBAUM AND WIFE SYLVIA K. QUATTLEBAUM**, (herein referred to as Grantors) do grant, bargain, sell and convey unto **CLEMENT E. Subject to existing easements, restrictions, set back lines, right of ways, limitations, if any, of record.

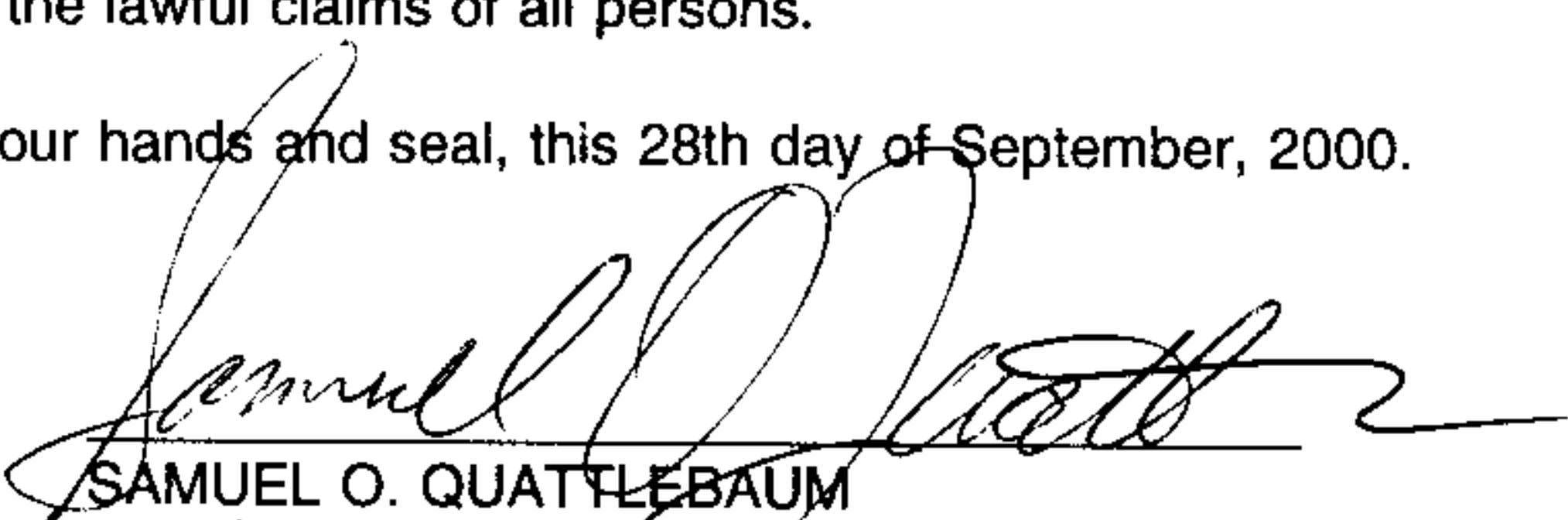
\$125,600.00 of the purchase price recited above was paid from a mortgage loan closed simultaneously herewith.

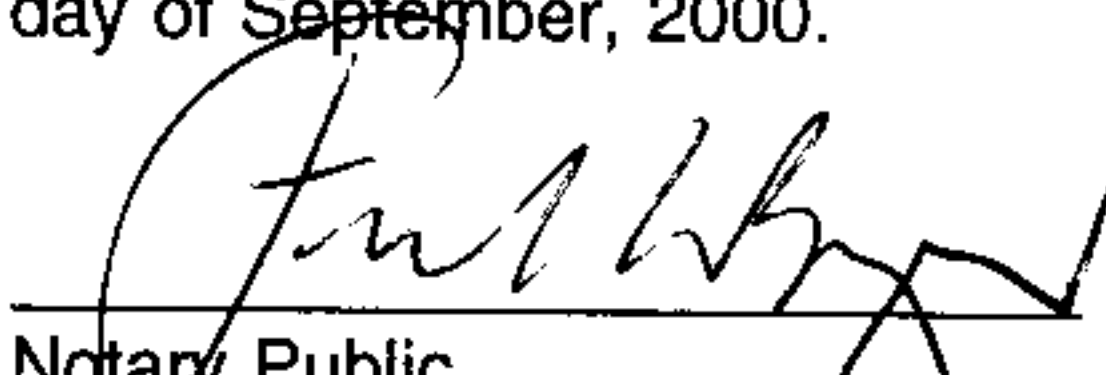
