AMENDMENT TO MORTGAGE

WHEREAS, this property is not the homestead of Mortgagor.


WHEREAS, the Mortgage secured a Note in the original principal amount of \$688,500.00 and all renewals and extensions thereof.

The term "Debt" as used in the Mortgage shall be defined to mean not only the Debt evidenced by the \$688,500.00 promissory note executed on April 13, 2000 and all interest thereon, and all extensions and renewals thereof, but also the \$117,750.00 advance or loan being made in connection herewith, all interest thereon, and all extensions, and renewals thereof.





All of the terms and provisions of the Mortgage not specifically amended herein, are hereby reaffirmed, ratified and restated. This Amendment amends the Mortgage and is not an novation thereof.
