ORDER


This matter came before the Court on September 25, 1998, at the hearing on the Motion for Summary Judgment by the Defendants/Counter-Plaintiffs, Spancom Services, Inc. and Donald K. Hambric, by and through their attorney of record, Alton M. Hambric, Esq., pursuant to Rule 56 of the Alabama Rules of Civil Procedure, The Court, sua Sponte, amends the Order of August 28, 1998, to reflect that said Defendants/Counter-Plaintiffs, and not the Plaintiff was directed by the Court to file the above stated motion. With evidentiary submissions, arguments and testimony submitted to the Court at the hearing by said Defendants/Counter-Plaintiffs, and Plaintiff not appearing or submitting any evidence in opposition thereto and for lack of the Plaintiff to prosecute the above styled action, the Court finds there is no genuine issue of material fact and that the Defenants/Counter-Plaintiffs are entitled to a judgment as a matter of law.

Accordingly, it is hereby ORDERED, ADJUDGED and DECREED that Final Summary Judgment, as per Rule 54(b) of the Alabama Rules of Civil Procedure, is granted in favor of the Defendants/Counter-Plaintiffs, Spancom Services, Inc., and


Donald K. Hambric, and against Plaintiff, James M. Glodt, in the amount of \$700,000.00 with court costs taxed to said Plaintiff.

In addition, the Court notes that all claims of the Plaintiff in this matter are hereby dismissed with prejudice for want of prosecution and this case is disposed of in its entirety.
