## STATEMENT OF REVOCATION OF VOLUNTARY DISSOLUTION PROCEEDINGS

Pursuant to § 10-3A-143 (b), Code of Alabama (1975)(as amended), RIVER OF LIFE CHRISTIAN CENTER, a non-profit corporation, submits the following "Statement of Revocation of Voluntary Dissolution Proceedings".

- (1) The name of the non-profit corporation is: RIVER OF LIFE CHRISTIAN CENTER
- (2) The names and respective addresses of its officers/directors are:

- (3) According to the Constitution and By-Laws of River of Life Christian Center, there are "no members, or no members entitled to vote"; and, a vote of the Board of Directors in office only was required for dissolution of the corporation, and correspondingly, a vote of the Board of Directors in office only would be required to revoke dissolution proceedings.

A meeting of the Board of Directors for River of Life Christian Center was held on October 9, 2000, in Shelby County, Alabama. Each member of the Board of Directors was notified, and a quorum was present. On said date and at said meeting, the Board of Directors adopted a resolution to REVOKE the voluntary dissolution proceedings for River of Life Christian Center heretofore initiated by the undersigned under date of December 20, 1998, and filed in the Office of the Judge of Probate of Shelby County, Alabama, on December 21, 1998, including but not limited (A.) to the "Statement of Intent to Dissolve", (B.) to the document regarding the action of this Board on May 13, 1998, (C.) to the "Articles of Dissolution" signed under date of December 20, 1998, by the undersigned Chairman and the past Secretary of River of Life Christian Center, and (D.) to the document "Transferring of Property and Assets In Accordance with Dissolution of a Non-Profit Corporation".


