Please accept this correspondence as notice that legal proceedings have been instituted to enforce the Declaration of Protective Covenants of Brook Highland, a Residential Subdivision, a copy of which is attached hereto as Exhibit A. Such Covenants are located in Book 194, Pages 254-280. As stated in Article VI, Section 6.03(c),

"...Notwithstanding the aforesaid, after the expiration of one year from the date of final completion of any such improvement or structure shall be deemed to comply with all of the provisions hereof unless notice to the contrary shall have been recorded in the office of the Judge of Probate of Shelby County, Alabama, or legal proceedings shall have been instituted to enforce such compliance. ..." (emphasis provided)
