**RESOLUTION OF

RESOLUTION # 00-10-09-06

WHEREAS, **ROBERT RICHARD WALTER** is the owner of all the property abutting on or adjacent to the following described property and the public easement over and across said property that is proposed to be vacated, situated in Shelby County, Alabama:

A 20 foot wide easement that is 10 feet each side of the common property line of lot 7 and lot 8 in Applecross subdivision as recorded in Map Book 6 Page 42 A & B in the Probate Office of Shelby County, Alabama being more particularly described as follows: Begin at the southwest corner of lot 7 also being the southeast corner of lot 8 and the right of way line of Chickering Circle, thence run in a northeasterly direction along the common line of said lots 7 and 8 to a point that is 20 feet south of Lake Heather and the end of said easement.

Situated in Shelby County, Alabama.

WHEREAS, the above owner is desirous of vacating said tract of land described above and the public easement over and across said property and requests that the assent of the County Commission of Shelby County, Alabama be given as required by law in such cases;

That after vacation of the above described tract of land and the public easement over and across said property, and all public rights and easements therein, convenient means of ingress and egress to and from the property will be afforded to all other property owners owning property in or near the tract of land embraced in said map, plat or survey by the remaining streets, avenues, or highways dedicated by said map, plat, or survey.

NOW THEREFORE, Be It Resolved the County Commission of Shelby County, Alabama that they do hereby assent to the said **ROBERT RICHARD WALTER** vacating said tract of land and the public easement over and across said property as described above and that the above described property be and the same is hereby vacated and annulled and all public rights and easements therein divested of the property.
