

AUCTIONEER'S DEED

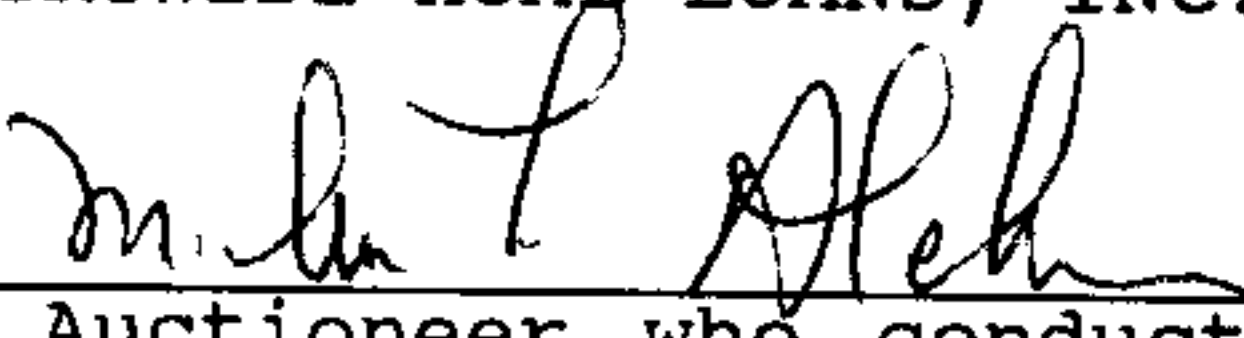

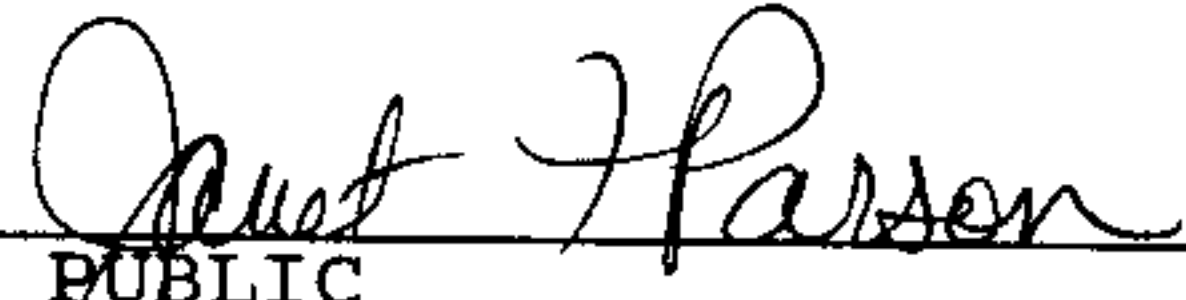
