To the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we,

(herein referred to as grantors) do grant, bargain, sell and convey unto

Rebecca A. Sokoria and Mahmoud A. Sokoria

Subject to existing easements, restrictions, encumbrances, rights of way, limitations, if any, of record.



Subject to ad valorem taxes for the current tax year.
