KNOW ALL MEN BY THESE PRESENTS,

That in consideration of TWO HUNDRED THOUSAND AND NO/100 DOLLARS (\$200,000.00), to the undersigned Grantors in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, **GEOFFREY A. HALL AND WIFE DEBORAH BERRY HALL**, (herein referred to as Grantors) do grant, bargain, sell and convey unto **MORGAN F. BARNES AND LAURALEE E. BARNES** (herein referred to as Grantees), as joint tenants, with right of survivorship, the following described real estate, situated in the State of Alabama, County of SHELBY, to-wit:

Deborah Barry Hall and Deborah Berry Hall are one in the same person.

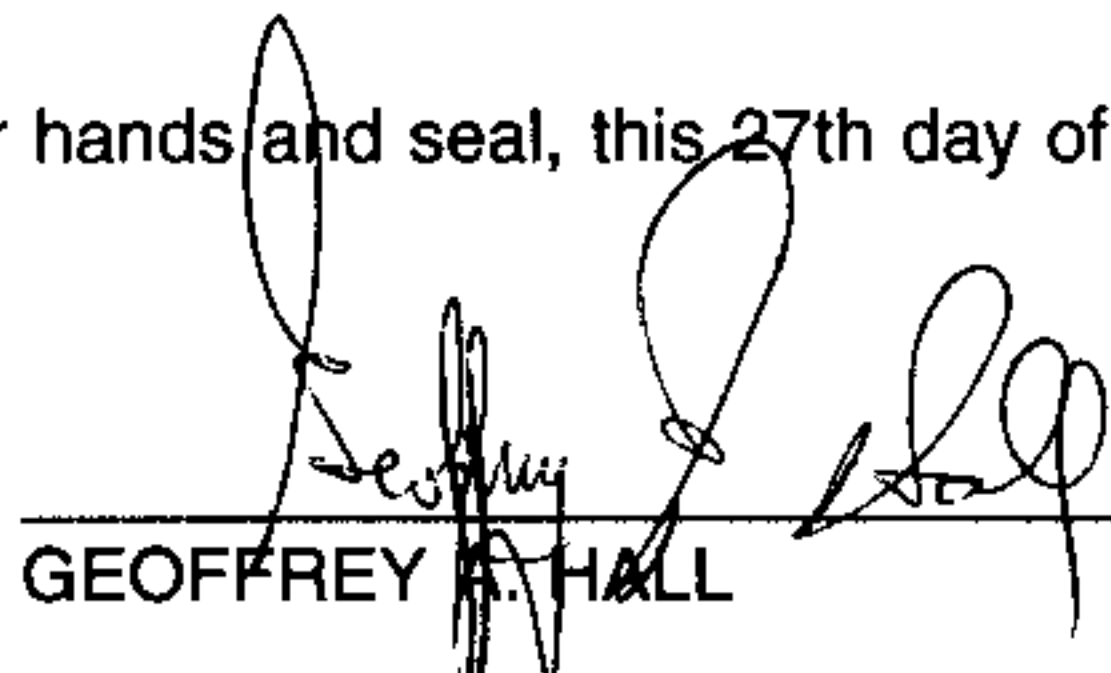
Subject to existing easements, restrictions, set back lines, right of ways, limitations, if any, of record.

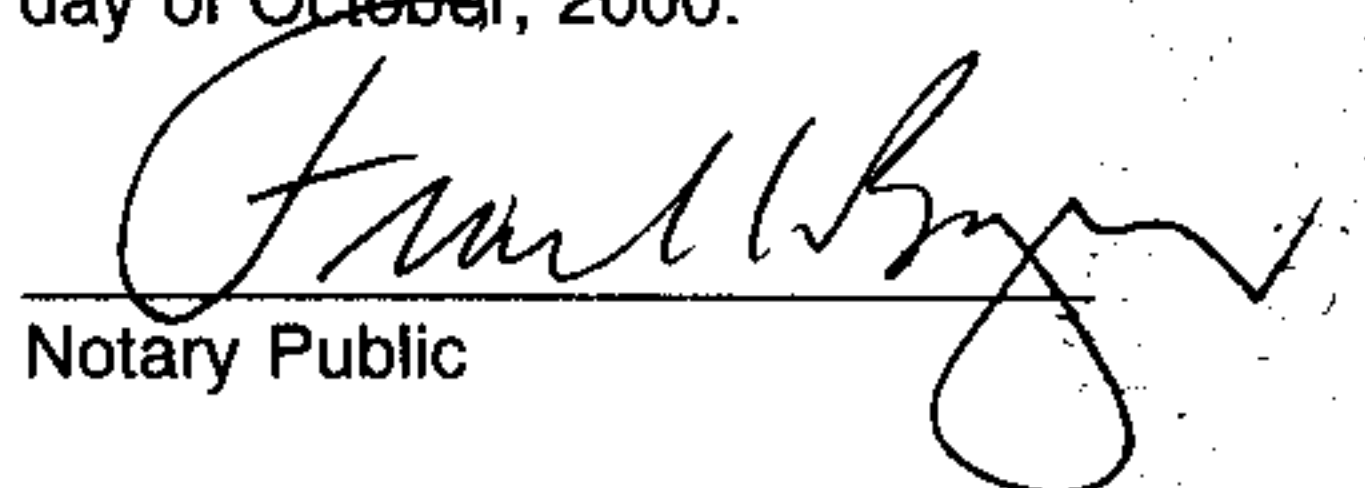
